1. PERFORMANCE OF THE FUND

- 1.1. A report by Deloitte describing the performance of the fund over the three month period to 31 March 2013 is attached as appendix one.

2. COMPLIANCE WITH STATUTORY REQUIREMENTS

- 2.1. The Local Government Pension Scheme (LGPS) investment regulations under which the Fund operates contain statutory limits for certain types of investments.

- a) Not more than 10% of the Fund can be invested in any one company.

On 31 March 2013 the largest share-holding was in BP which represented 1.53% of the Fund.

- b) Not more than 35% of the Fund can be invested in collective investment schemes managed by a single manager.

On 31 March 2013, the largest element of the portfolio in collective investment schemes was the passive UK (13.26%) and Global (18.64%) mandates both managed by State Street. This represented 31.90% of the Fund.

- c) Not more than 5% can be invested in employer – related investments.

On 31 March 2013 the Fund had no employer related investments.

- 2.2. The Fund is therefore complying with statutory requirements.
