LEARNING SERVICES OVERVIEW AND SCRUTINY COMMITTEE

1. CONSTITUTION

Ten Members of the Council (8 Majority Party Members and 2 Minority Party Members) but shall not include a Member of the Cabinet; 4 coopted Members with voting rights ie one co-opted representative each from the Church of England and Roman Catholic Diocesan Education Boards and two Parent Governor Representatives. 2 co-opted Members without voting rights, ie 2 Headteachers of Westminster maintained schools.

2. TERMS OF REFERENCE

 - (iv) Adult Education.
- (b) The Overview and Scrutiny functions in respect of all matters in relation to grants to and the City Council's relationship with the Voluntary Sector, having regard to any views of the Arts and Leisure Sub-Committee concerning grants relating to matters within the terms of reference of that Sub-Committee.
- (c) The Overview and Scrutiny functions in respect of Libraries, Leisure Centres and Facilities, Sports and Arts to be more fully carried out by the Arts and Leisure Overview and Scrutiny Sub-Committee. The Overview and Scrutiny functions, including all matters in

relation to grants and the Council's relationship with the voluntary sector, in respect of Libraries, Leisure Centres and Facilities, Sports, and Arts, to be more fully carried out by the Arts and Leisure Overview and Scrutiny Sub-Committees. The Overview and Scrutiny function in respect of all other grants matters within the terms of reference of the Cabinet Member for Leisure and Lifelong Learning and the Council's relationship with the voluntary sector excepting such matters to rest with the Learning Services Overview and Scrutiny Committee.

(c)(d) The Overview and Scrutiny functions in respect of Looked After Children, Child Protection, Children with Disabilities, Children in Need, Special Educational Needs and Behavioural Problems and the Youth Offending Team to be more fully carried out by the Vulnerable Children Overview and Scrutiny Sub-Committee.

(d)(e) To participate as necessary in Best Value reviews by:
