## **1. Executive Summary**

- 1.1 The report formally advises the Licensing Committee of the Licensing Urgency Sub-Committee decisions on 17<sup>th</sup> February 2012 relating to the adoption of Standard Conditions which will apply generally to all Sexual Entertainment Venue (SEV) licences under the Local Government (Miscellaneous Provisions) Act 1982 (the Act).
- 1.2 Although applying generally to all SEV licences, any of the Standard Conditions may be modified or waived by the council when considering individual applications for the grant or variation of a SEV licence.

## **2. Recommendations**

- 2.1 That the Licensing Committee notes the contents of the 17<sup>th</sup> February 2012 Licensing Urgency-Sub Committee report and decision relating to the Sexual Entertainment Venue Standard Conditions.

## **3. Background**

- 3.1 On the 17<sup>th</sup> February 2012 the Licensing Urgency Sub-Committee formally agreed to make regulations to adopt Standard Conditions which apply generally to all Sexual Entertainment Venues licences under the Local Government (Miscellaneous Provisions) Act 1982 (the Act). This decision is attached at Appendix 2 to this report.

3.2 The Licensing Urgency Sub-Committee report, attached to this report as Appendix 1, was put before a Licensing Urgency Sub-Committee due to the need to make the Standard Conditions available to applicants to allow them sufficient time to make applications prior to the second appointed day of 1<sup>st</sup> April 2012.
