### 3. Background Information

3.1 The Council, on 7 May 2008, appointed 4 Independent Members to the Standards Committee for a period of one year until the Annual Council Meeting on 13 May 2009. Each of the four existing Independent Members has indicated their willingness to serve for a further period as set out below:

Lord Dennis Stevenson to May 2011 Mrs Elizabeth Peace to May 2011 Lord Richard Best to May 2012 The Very Reverend John Hall to May 2012

- 3.2 The Standards Board for England recommend that Independent Members should sit on the Standards Committee for differing periods so that all the experience gained is not lost at the same time. They further recommended that the maximum period served be eight years.
- 3.3 Independent Members must be chosen in a fair and open way. A person can only be an Independent Member if that person:
  - has not been a member or employee of the Council within the five years before the date of appointment.
  - is not a Member or officer of that or any other relevant authority;
  - is not a relative or close friend of a Member or employee of the Council;
  - has submitted as application for the appointment;
  - has been approved by a majority of the members of the Council;
- 3.4 It is a further requirement that the position of Independent Member be advertised in at least one newspaper distributed in the Council's area. This was done when the Council recruited last year. In addition the positions were advertised in the Evening Standard and use was made of a recruitment agency, Primetimers, which specialises in recruiting for the voluntary sector particularly from those people recently retired.
- 3.5 As the requirements set out in paragraph 3.3 and 3.4 have been met at the time of the original appointments it is in order for the Council to re-appoint the existing Independent Members.
