1. **Executive Summary**

This paper explores opportunities for the policy and scrutiny function of Westminster City Council to engage and have influence beyond the immediate borough and tri-borough area. It sets out a series of options for each of the four principal Policy & Scrutiny committees, whilst suggesting a rolling programme of updates in relation to further opportunities.

2. Background

Westminster City Council's scrutiny function supports the Council's ongoing commitment to quality, transparent and effective governance. Under Section 21 of the Local Government Act 2000 local authorities are required to appoint at least one committee to provide overview and scrutiny. In Westminster these are termed Policy and Scrutiny Committees, of which there are currently four:

- Adult, Health and Community Protection;
- Children & Community Services;

- Environment;
- Housing, Finance and Customer Services

Additionally, the Westminster Scrutiny Commission (the Commission) is responsible for overseeing their activities and resolving any disputes. Policy & Scrutiny Committees are divided between Cabinet Member portfolios for reporting purposes. Within their terms of reference, the general role of Policy and Scrutiny Committees as defined in the Westminster Constitution is to:

- review and/or scrutinise decisions made or actions taken in connection with the discharge of any of the Council's functions;
- make reports and/or recommendations to the full Council and/or the executive and/or any policy, joint or area committee in connection with the discharge of any functions;
- consider any matter affecting the area or its inhabitants; and
- exercise the right to call-in, for reconsideration, decisions made but not yet implemented by the executive.

The third of the above points forms the principal basis for this report; in exploring opportunities for the O&S function of Westminster City Council to have influence and impact beyond the immediate City and tri-borough area. This could take the form of a more formal programme of public affairs activity or an increased amount of external positioning.

3. General points for consideration

Public affairs activities undertaken by Policy and Scrutiny Committees occurs in consultation with senior officers, Cabinet Members and external experts where appropriate, but would not necessarily be dependent upon them nor required to hold the same position on a given issue.

Scrutiny committees and officers are typically not advised or consulted in relation to most public affairs activities relating to the Council, except where the primary duty of the Committee is to provide formal responses (such as the Health Committee and its role in respect to the NHS).

Consideration should be given to limiting overlap and duplication – but which fully involve Policy & Scrutiny Committees of the Council. Submissions and representations organised independently would represent a position of the committee, rather than a position of the organisation, executive or council as a whole, whilst the Committee itself could seek endorsement from the wider Council. Consideration would need to be given to potential conflicts between the position of the Committee and that of the Council as a whole.

Where relevant, especially in relation to services which are shared, consideration could be given to providing evidence and responses on a Tri-

Borough basis. When responding from across three O&S Committees, opportunities such as these may provide a stronger voice. Currently, when the Adults, Health & Community Protection Committee respond to Trust "Quality Accounts", these are often done on a Tri-Borough or Bi-Borough basis dependent on the referral pattern of the NHS Trust in question.

4. Public affairs opportunities

In relation to the non-executive policy (overview) and scrutiny function of the Council, public affairs and positioning activities could include, but are not limited to:

- promotion of Committee activities and recommendations (to community, media, social media, etc)
- commissioning of distinctive research (such as the recent violence against sex workers and investigation into novel psychoactive substances)
- responding to formal consultations (departmental, select committees, EU, non-government, third-sector, industry based, etc) (such as the Adults, Health & Community Protection Committee submission to the Keogh Review of Acute Care and the Home Office consultation into immigration and the NHS)
- direct advocacy to decision makers (ministers, executives, regulators etc) (such as the City Management Committee appeals to Ofwat)

The content of these activities could range from promotion of items on existing work programmes through to important strategic issues affecting the area (public health issues, community safety, etc) or specific causes.

Resource requirements will vary considerably depending on the type of public affairs activities. If committees are moved to do more of this type of activity, then consideration will need to be given to how this will be resourced, especially given the size and scale of the potential opportunities.

The following section of the report outlines some of the current opportunities available to Committees, and a rolling list could be kept to update Chairmen of future opportunities.
