5. PADDINGTON BRIDGE (LTVA) PROJECT – PROPOSED RESOLUTION OF DISPUTE WITH NETWORK RAIL (Report of the Director of Transportation – agenda item 5)

5.1 David Ferrett, the Project Director, introduced this report which updated Members on the mediation with Network Rail over the additional possession related costs and set out the proposed negotiated settlement.

- 5.2 Members discussed the report and asked questions of the officers present.
- 5.3 With regard to a question regarding the robustness of aspects of the settlement, officers advised that they would take further legal advice on the proposed wording of the final settlement document to clarify the terms and safeguard the Council's position. In particular, there would be no ambiguity that a discount to the total Network Rail cost of £500,000 had been secured.
- 5.4 David Ferrett also outlined the Council's funding agreement with Transport for London and Members discussed and asked questions relating to this issue.

RESOLVED:

- 1. That the proposed negotiated settlement with Network Rail, as set out in paragraph 4.2 of the report, be noted and endorsed.
- 2. That the Director of Transportation be authorised to finalise the detail of the proposed negotiated settlement with Network Rail as set out in the report.

Reasons for Decisions

The LTVA Project was approved in June 2003 on the basis that the City Council would bear a £22.75m share of a £62.5m cost plan. The negotiated settlement is expected to give a very favourable return against capital budget and avoids the risk and uncertainty about the financial outcome and the significant delay if litigation is pursued.
