Peter Large Head of Legal & Democratic Services 8 May 2015 In considering applications for premises licences under the Licensing Act 2003, the subcommittee is advised of the following:

POLICY CONSIDERATIONS

The City of Westminster statement of licensing policy applies to all applications where relevant representations have been made. The Licensing Sub-Committee is required to have regard to the City of Westminster statement of Licensing Policy and the guidance issued by the Secretary of state under Section 182 of the Licensing Act 2003.

GUIDANCE CONSIDERATIONS

The Licensing Authority is required to have regard to any guidance issued by the Secretary of State under the Licensing Act 2003.

PERMITTED TEMPORARY ACTIVITIES

The licensee of any premises is entitled under the Licensing Act 2003 to apply for permission to hold temporary events, authorising licensable activities instead of or in addition to any activities that may be authorised by a premises licence, subject to the following restrictions:

- 1) No more than 12 events over a total of 21 days may be held at any one premises in any year
- 2) Each event must last for no more than 168 hours
- 3) There must be 24 hours between each event
- 4) The number of people at each event must be less than 500.

A Temporary Event Notice for each event (a TEN) is required to be given to the licensing authority, the police and environmental health service no later than 10 working days before the event for a 'standard' TEN or 5 to 9 working days before the event is due to begin for a 'late' TEN. The licensing authority is required to send an acknowledgement by the next working day.

Once a Temporary Event Notice is given the police and environmental health service have a right to object to the event if they are satisfied that the event will undermine any of the licensing objectives of preventing crime and disorder, prevention of public nuisance, protection of children from harm and promotion of public safety. They must serve an objection notice stating their reasons as to why the objectives would be undermined to the licensing authority and the premises user within 3 working days of receiving a copy of the TEN. The licensing authority is required to hold a hearing and may issue a counter notice which will prevent the event taking place.

LIVE MUSIC ACT 2012

The Live Music Act amends the Licensing Act 2003 by:

- removing the licensing requirement for amplified live music taking place between 8am and 11pm before audiences of no more than 200 persons on premises authorised by a premises licence or club premises certificate to supply alcohol for consumption on the premises (at a time when those premises are open for the purposes of being used for the supply of alcohol for consumption on the premises), subject to the right of a licensing authority to impose conditions about live music following a review of a premises licence or club premises certificate
- removing the licensing requirement for amplified live music taking place between 8am and 11pm before audiences of no more than 200 persons in workplaces not otherwise licensed under the 2003 Act (or licensed only for the provision of late night refreshment)
- removing the licensing requirement for unamplified live music taking place between 8am and 11pm in any place, subject to the right of a licensing authority to impose conditions about live music following a review of a premises licence or club premises certificate relating to premises authorised to supply alcohol for consumption on the premises
- removing the licensing requirement for the provision of entertainment facilities
- widens the licensing exemption for live music that is integral to a performance of Morris dancing or dancing of a similar type, so that the exemption applies to both live or recorded music instead of just unamplified live music in that instance.

1. Relevant representations

1.1 The Environmental Health Service has made an adverse representation against this application as the additional hours requested for the Late Night refreshment in the Garden and on Sundays in the main premises may have the likely effect of increasing public nuisance in the area. They may suggest additional conditions they think appropriate but are waiting to

assess the noise report that the applicant has commissioned and was received on 5.5. They refer to the removal of the toughened glasses drinking condition, which is omitted , in error from the current issued licence but should figure and is included in Appendix B. They also refer to complaints involving nuisance and other matters that the licensing inspectors have investigated.

- 1.2 The Metropolitan Police Service have made a representation against this application. Further elaborative information has been sought.
- Twelve local residents have made adverse representations against the application on the grounds of protecting children from harm, protection of Public Safety, Prevention of Crime and Disorder and Prevention of Public Nuisance. They include concerns that the users of the premises are already creating public nuisance of late night noise, when they leave and that any additional hours granted would worsen this. They say that noise from cars and their owners already affect residents sleep and that it is a highly residential area.
- 1.4 There are comments that the additional hours will create more public nuisance with shouting and fighting resulting in late night noise already. Users of the premises often have loud music on in their cars and it is said that the management cannot control this. But that extending the hours would make the noise extend well into the night.

2. Policies Applicable

- 2.1 The following policies within the City Of Westminster Statement of Licensing Policy apply: Policy HRS1:
 - (i) Applications for hours within the core hours set out below in this policy will generally be granted, subject to not being contrary to other policies in the Statement of Licensing Policy.
 - (ii) Applications for hours outside the core hours set out below in this policy will be considered on their merits, subject to other relevant policies.

Policy MD1:

Applications will only be granted if it can be demonstrated that the proposal meets the relevant criteria in Policies CD1, PS1, PN1 and CH1.

Policy PB1:

Applications will only be granted if it can be demonstrated that the proposal meets the relevant criteria in Policies CD1, PS1, PN1 and CH1.

3. Summary

- 3.1 The Licensing Sub-committee may refuse, grant in full or grant in part this proposal, having taken into account the representations received and Westminster's Statement of Licensing Policy. The decision taken should promote the licensing objectives of:
 - prevention of public nuisance,
 - prevention of crime & disorder,
 - public safety and
 - protection of children from harm.
- 3.2 Where the committee is minded to grant the licence it will be granted subject to the mandatory conditions and conditions consistent with the operating schedule modified to such extent as the authority considers appropriate for the promotion of the licensing objectives detailed in Appendix D to this report.

CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE AND CONDITIONS PROPOSED BY A PARTY TO THE HEARING

When determining an application for a new premises licence under the provisions of the Licensing Act 2003, the licensing authority must, unless it decides to reject the application, grant the licence subject to the conditions which are indicated as mandatory in this schedule.

At a hearing the licensing authority may, in addition, and having regard to any representations received, grant the licence subject to such conditions which are consistent with the operating schedule submitted by the applicant as part of their application, or alter or omit these conditions, or add any new condition to such extent as the licensing authority considers appropriate for the promotion of the licensing objectives.

This schedule lists those conditions which are consistent with the operating schedule, or proposed as appropriate for the promotion of the licensing objectives by a responsible authority or an interested party as indicated. These conditions have not been submitted by the licensing service but reflect the positions of the applicant, responsible authority or interested party and have not necessarily been agreed

Conditions: On Current Licence -

Mandatory:

- No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
- No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
- 3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises -
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
 - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- 7. The responsible person must ensure that -
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

- 8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 8(ii) For the purposes of the condition set out in paragraph 8(i) above -
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

"permitted price" is the price found by applying the formula -(b)

P = D+(DxV)

Where -

P is the permitted price,

D is the amount of duty chargeable in relation to the alcohol as if the duty were (ii) charged on the date of the sale or supply of the alcohol, and

V is the rate of value added tax chargeable in relation to the alcohol as if the (iii) value added tax were charged on the date of the sale or supply of the alcohol;

- "relevant person" means, in relation to premises in respect of which there is in force a (c) premises licence
 - the holder of the premises licence, (i)

the designated premises supervisor (if any) in respect of such a licence, or (ii)

- the personal licence holder who makes or authorises a supply of alcohol (iii) under such a licence;
- "relevant person" means, in relation to premises in respect of which there is in force a (d) club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- "value added tax" means value added tax charged in accordance with the Value Added (e) Tax Act 1994.
- Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) 8(iii). not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph (1) 8(iv). 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - The permitted price which would apply on the first day applies to sales or supplies of (2) alcohol which take place before the expiry of the period of 14 days beginning on the second day
- The terminal hour for late night refreshment on New Year's Eve is extended to 05:00 on New 9. Year's Day

Conditions which reproduce the effect of any restriction imposed on the use of the premises by specified enactment

Annex 2 – Conditions consistent with the operating Schedule

- There shall be no entry to the premises one hour before the end of all licensable activities. 10.
- No adult entertainment paid for by the company of a nude physical nature shall be permitted 11. on the premises.
- There shall be no promotions that encourage illegal, irresponsible or immoderate consumption 12. of alcohol.
- Free drinking water shall be available to all customers. 13.

- Notices shall be displayed around the premises asking patrons to leave quietly. 14.
- Deliveries shall be conducted during daytime to control noise nuisance. 15

Annex 3 – Conditions attached after a hearing by the licensing authority

- Alcohol may be sold or supplied: 16.
 - On Monday to Thursday, 10:00 to 23:30 (a)
 - On Friday and Saturday, 10:00 to 00:00 (b)

On Sundays, 12:00 to 22:30 (c)

On New Year's Eve from the end of permitted hours on New Year's Eve to the start of (d) permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).

NOTE - The above restrictions do not prohibit:

during the first twenty minutes after the above hours the consumption of the alcohol on (a) the premises;

during the first twenty minutes after the above hours, the taking of the alcohol from the (b)

premises unless the alcohol is supplied or taken in an open vessel;

during the first thirty minutes after the above hours the consumption of the alcohol on (c) the premises by persons taking table meals there if the alcohol was supplied for consumption as ancillary to the meals;

the sale or supply of alcohol to or the consumption of alcohol by any person residing in (d)

the licensed premises;

the ordering of alcohol to be consumed off the premises, or the despatch by the vendor (e) of the alcohol so ordered;

the sale of alcohol to a trader or registered club for the purposes of the trade or club; (f)

the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale (g) or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces.

In this condition, any reference to a person residing in the premises shall be construed as including a person not residing there but carrying on or in charge of the business on the premises.

- All persons under 18 years of age to be off the premises by 21:00 hours unless 17. accompanied by an adult and partaking in a table meal.
- The premises will maintain a comprehensive CCTV system that ensures all areas of the 18. licensed premises are monitored including all entry and exit points, the street environment and which enable frontal identification of every person entering in any light condition. All cameras shall continually record whilst the premises are open to the public and the video recordings shall be kept available for a minimum of 31 days with time and date stamping.

Tape recordings shall be made available to an authorised officer or a police officer

together with facilities for viewing.


- The recordings for the preceding two days shall be made available immediately on (ii) request. Recordings outside this period shall be made available on 24 hours notice (subject to the Data Protection Act 1998).
- Noise and vibration will not be allowed to emanate from the premises so as to cause a 19. nuisance to nearby property.
- The external doors and windows shall be kept closed after 23:00 except for immediate access 20. and egress of persons.

- 21. All waste is to be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times.
- 22. No rubbish including bottles will be moved, removed or placed outside between 23:00 hours and 07:00 hours.
- 23. A sound limiting device shall be located in a separate and remote lockable cabin form the volume control and must be fitted to the musical amplification system to be set at a level determined by and to the satisfaction of an authorised officer of the environmental health services community protection department to ensure that no noise nuisance is caused to local residents. The operational panel of the noise limiter shall then be secured to the satisfaction of an officer from the environmental health service. The keys securing the noise limiter cabinet shall be held by the applicant only, and shall not be accessed by any other person. The limiter shall not be altered without prior agreement with the environmental health service.
- 24. No alteration or any modification to any existing sound system(s) should be effected without prior knowledge of an authorised officer of the environmental health services.
- 25. There are to be no more than two live musicians at any one time.
- 26. The beer garden is to be cleared of patrons by 23:00.
- 27. The inner door and all windows at the premises are to be kept closed at all times when licensable activities are taking place.
- When a customer chooses to pay by credit/debit card, he/she shall be presented with an itemised bill upon final payment showing details of all drinks and food purchased.

Condition 29, missing from Licence since 2011

Conditions consistent with the operating schedule

- 29. Toughened drinking glasses shall be used in the premises.
- SIA registered door staff will be employed at the premises.
- Noise will not be allowed to emanate from the garden so as to cause noise to any neighbouring residential premises.
- 32. After 23:00 hours all patrons to enter via the main Edgware Road save in the case of emergency
- 33. No use of the interior of the premises by patrons after 23:30 Sunday Thursday and 00:00 hours on Friday and Saturdays, save for access and egress of the premises and to use the toilets.

1 Introduction

- 1.1 Vanguardia have been commissioned by Dar Marrakesh to carry out an acoustic assessment relating to its proposed premises licence variation at 422 Edgware Road, London W2 1EG.

 The premises licence variation relates to extended hours of operation of the rear garden area.
- 1.2 The rear garden area comprises seating space for approximately 60 customers on tables of two and four persons, which is enclosed on all sides by a brick wall and partial canopy overhead. There is a gap around the perimeter of the canopy to allow for natural ventilation of the outdoor smoking area.
- 1.3 The purpose of this report is to assess the impact of noise generated in the garden area on nearby noise-sensitive receptors.
- 1.4 A glossary of acoustic terms is shown in Appendix A

Consultants' Experience

- 1.5 Vanguardia Consulting is an independent acoustic consultancy specialising in the field of sound, noise and acoustics related to entertainment venues. - 1.6 The consultants have successfully provided sound management advice, including noise control, at over 1000 concerts during the past 30 years. These concerts have ranged from relatively small scale events at green field sites to major events staged at national stadia providing entertainment for tens of thousands of people.
- 1.7 The company director of Vanguardia also sat on the UK Noise Council Working Party which prepared the Code of Practice on Environmental Noise Control at Concerts (1995). They have also managed Government research projects related to sound and noise aspects of the entertainment business.
- 1.8 As well as the provision of sound and acoustic design/management for entertainment venues, the company deals with the whole range of acoustic, noise and vibration issues and our staff have presented expert testimony at planning and licensing hearings, magistrates and high courts, Judicial Reviews and House of Commons and House of Lords Select Committees.

Proposed License Variation

- 1.9 The rear garden area is currently licensed to operate until 23:00 hours seven days per week.
- 1.10 It is proposed that the hours of operation of the rear garden are extended as follows:
 - Sunday to Thursday until midnight
 - Friday and Saturday until 02:00 AM
- 1.11 The capacity of the rear garden area is sixty persons.

2 Noise Criteria

- 2.1 Vanguardia have liaised with Mr Anil Drayan at Westminster City Council (WCC), regarding the noise criteria that are to be applied to this application.
- 2.2 During a telephone conversation on 22nd April 2015 Mr Drayan advised that it would be necessary to demonstrate that the noise from use of the rear garden would not disturb nearby residents who may be asleep with open windows during warm weather.
- 2.3 This requirement broadly relates to the stated licensing objective of prevention of public nuisance.
- 2.4 Mr Drayan advised that an objective acoustic criterion such as that, "the A weighted sound pressure level shall not exceed a value of 10 dB below the minimum external background level expressed as $L_{A90,\ 15\ mins}$ " would be applied only to steady state noise such as plant and machinery, and that no such objective condition would be applied to noise generated by human voices within the rear garden area.
- 2.5 Further details on the rationale supporting this criterion are shown in condition C47AB as specified in the WCC Standard Paragraph References available here:

 http://transact.westminster.gov.uk/docstores/publications-store/Planning/StandardConditions.pdf
- 2.6 Mr Drayan further advised that the onus would be with the applicant to demonstrate that the proposed variation would not cause disturbance to nearby noise sensitive receptors, and that no objective noise criteria are proposed by WCC.
- 2.7 Vanguardia have selected relevant noise criteria relating to night-time noise within dwellings from current standards in order to demonstrate the impact of the proposed variation, which are shown below.

- 2.8 In the absence of objective criteria being specified by WCC this report will consider the impact of new noise, over and above the existing local ambient noise levels, generated by the proposed premises licence variation.
- 2.9 Prevention of public nuisance after 23:00 hrs will relate to prevention of sleep disturbance inside dwellings, rather than protection of outdoor spaces such as balconies, terraces and outdoor living areas. For this reason only criteria relating to bedrooms indoors will be considered.

3 Noise Assessment

Existing Ambient Noise Levels – unattended survey

- 3.1 In order to determine the effect of the proposed variation, two noise surveys were carried out at the premises.
- 3.2 An unattended ambient noise survey was carried out from 26th March to 30th March 2015. The purpose of this survey was to establish baseline noise levels, in accordance with good practice.
- 3.3 The microphone was located at approximately 4m height above the side boundary wall of Dar Marrakesh on Boscobel Street, London W2. This is representative of noise levels at the nearest noise sensitive receptor, which is understood to be on the opposite side of Boscobel Street from Dar Marrakesh at the junction with Venables Street.
- 3.4 The mode (statistically most common) value for $L_{Aeq, 15 \, min}$ during the hours of the proposed premises licence variation was 61dB. This is indicative of the ambient noise level.
- 3.5 The lowest measured value of $L_{AF90, 15 \, min}$ during the hours of the proposed variation was 53dB. This is indicative of the underlying background noise level.
- 3.6 Survey equipment: MP1 Larson Davis LxT serial number 3812. Larson Davis CAL200 calibrator serial number 4622. Calibration certificates available on request.




Figure 2: Plan showing measurement location plan for unattended survey

Existing Ambient Noise Level – attended survey

- 3.7 A further attended noise survey was subsequently carried out on Friday 17th April 2015. The purpose of this survey was two-fold; to establish the sound attenuation characteristics of the rear garden walls and partial canopy, along with typical source noise levels in the rear garden area whilst in use by customers. Also to verify the ambient noise levels measured during the unattended survey.




Figure 1: Locations of attended monitoring positions

- 3.8 Three measurement points were utilised in the survey, which are described below and shown in figure 1.
- 3.9 MP1: The Sound Level inside the outdoor seating area was located discreetly in one corner of the garden, with the microphone elevated approximately 1.5m above ground level but within 0.5m of a reflective surface (the perimeter wall) the internal speakers were well screened within the roofing structure, and were not audible above the level of speech at the microphone location. The garden area was busy with people throughout the measurement until approximately 22:40 when people started to leave the venue.
- 3.10 MP2: The sound level meter was located on the corner of Venables Street, at the junction of Boscombe Street. The dominant noise source was the sound of an extractor fan under the control of the Pizza Shop, which was turned off at 23:00 hours. There were also high levels of traffic noise throughout from vehicle movement on Edgware Road, as well as local vehicle movement on Boscobel Street. Frequent pedestrian movement was also present throughout the measurement period. Some customer noise was audible though not dominant throughout the measurement period.
- 3.11 MP3: The sound level meter was located in line with the façade of the flats to the rear of Dar Marrakesh. Traffic noise from Edgware Road was present throughout the measurement period, varying levels of local traffic were also present on Boscobel Street with frequent pedestrian movement along the street. Noise was present though not dominant from Dar Marrakesh throughout the measurement period.

3.12 Survey equipment: MP1 Larson Davis LxT serial number 3815, MP2 & MP3 Larson Davis LXT serial number 3812. Larson Davis CAL200 calibrator serial number 4622. Calibration certificates available on request

Noise Predictions

- 3.13 Calculations were then undertaken to predict the noise levels in terms of L_{Aeq} and L_{Amax} (as recommended in Guidelines for Community Noise (WHO 1999) at the nearest noise sensitive receptor.
- 3.14 The logarithmic average measured level in terms of L_{Aeq} within the rear garden area, when operating at full capacity of approximately 60 people was 81 dB. This equates to a vocal effort of 66 dB per person, assuming that one in every two patrons is speaking simultaneously.
- 3.15 The 95th percentile (calculated to eliminate outlying values) of L_{Amax} levels measured within the rear garden area was 94dB, when operating at full capacity of approximately 60 persons.
- 3.16 The measured screening attenuation of the partial canopy structure was 10 dB, at first floor window level of approximately 4m height. This was calculated by carrying out time-synchronous measurements above and below the canopy.
- 3.17 Accounting for a distance of 15.5m from the nearest perimeter wall of the Dar Marrakesh, the attenuation due to distance is 23.8 dB. This represents a worst-case scenario, as many of the customers will be several meters further away from the perimeter wall.
- 3.18 Applying corrections for attenuation and distance, the resultant level at nearest noise sensitive receptor is as shown in the table below. This follows a basic prediction considering the nature and noise level of the sources, the propagation along the paths between sources and receptors and the location of the receptors.

- 3.19 The simplest procedure for rating indoor noise levels is to measure them in terms of integrated A-weighted sound pressure levels, as measured by LAeq, and this is a valid descriptor for more-or-less continuous noises or those of individual events with randomly varying sound pressure levels.
- 3.20 Because the noise from the proposed licence variation is likely to include discrete noise events, the additional use of LAmax has been implemented in the assessment.

4 Noise Assessment

Assessment Methodology

- 4.1 Existing ambient noise levels in the locality are already high and in excess of the World Health Organisation Guidelines for Community Noise (please refer to 2.3 above). For this reason the report will examine whether there is likely to be any significant relative change in noise levels, caused by new noise relating to the proposed premises licence variation.
- 4.2 Guidelines exist for environmental noise impact assessment published by IEMA in 2014, ranking the sensitivity of the receptor to noise level exposure. Relative changes to noise levels are rated as follows:

4.3 The likely changes in indicators resultant from the proposal have been assessed by addition of the calculated new noise levels to existing ambient noise levels, and the resultant changes in noise levels are shown in the table below.

4.4 The noise levels in the table above correlate well with the subjective observations of the acoustic consultant carrying out the attended noise survey on Friday 17th April 2015. These observations are that, when observed outside the nearest noise sensitive receptors, conversation from the rear garden area of Dar Marrakesh was audible but not dominant in the lulls between traffic and pedestrian movements, but masked when local noise sources were high.

4.5 Comparing the likely new noise levels with the standards in table 1 above, it can be seen that impact is likely to be negligible:



5 Conclusion

- 5.1 Vanguardia have assessed the existing ambient noise levels and the likely impact of the new noise generated at the nearest noise sensitive receptor as a result of the proposed premises licence variation, which seeks to extend the hours of operation of the rear garden area.
- 5.2 No objective noise criteria were specified by Westminster City Council relating to the application, and so Vanguardia have selected appropriate criteria from current standards as stated at table 1. Impacts for both noise metrics L_{Aeq} (relating to steady-state noise) and L_{Amax} (referring to short-term discrete events) have been assessed.
- 5.3 Vanguardia have predicted the internal night-time noise level change due to the new noise, and have determined that impact based on relative change in noise level in terms of L_{Aeq} will be negligible, and in terms of L_{Amax} will be none.



APPENDIX B / Glossary of Terms

- A.1 Noise is defined as unwanted sound. The range of audible sound is from 0dB to 140dB, which is taken to be the threshold of pain. The sound pressure detected by the human ear covers an extremely wide range. The decibel (dB) is used to condense this range into a manageable scale by taking the logarithm of the ratio of the sound pressure and a reference sound pressure.
- A.2 The frequency response of the ear is usually taken to be about 18Hz (number of oscillations per second) to 18,000Hz. The ear does not respond equally to different frequencies at the same level. It is more sensitive in the mid-frequency range than at the lower and higher frequencies, and because of this, the low and high frequency component of a sound are reduced in importance by applying a weighting (filtering) circuit to the noise measuring instrument. The weighting which is most used and which correlates best with the subjective response to noise is the dB(A) weighting. This is an internationally accepted standard for noise measurements.
- A.3 The ear can just distinguish a difference in loudness between two noise sources when there is a 3dB(A) difference between them. Also when two sound sources of the same noise level are combined the resultant level is 3dB(A) higher than the single source. When two sounds differ by 10dB(A) one is said to be twice as loud as the other.

A.4 The subjective response to a noise is dependent 130 - 140 120 = 130 not only upon the sound pressure level and its frequency, but also its intermittency. Various 100 - 110 indices have been developed to try and correlate 80 - 90 annoyances with the noise level and its 70 - 8060 - 70 fluctuations. The parameter used for this 50 - 60 measure is Equivalent Continuous Sound 40 - 50 Pressure Level (LAeq). The A-weighted sound 30 - 40pressure level of a steady sound that has, over a 20 - 3010 - 20 given period, the same energy as the fluctuating 0 - 10 sound under investigation. It is in effect the energy average level over the specified



measurement period (T) and is the most widely used indicator for environmental noise. A few examples of noise of various levels are given right:

Licensing Application to Increase Hours For Late Night Refreshment in Rear Garden and Remove Requirement to Use Toughened Glasses

INTRODUCTION

I David Seaborn Davies (DSD) was asked by Mr Zak Derissy the owner of the above premises to attend the premises and carry out an independent review of all matters pertaining to his application. In essence to demonstrate independently that the premises was well run and-the management had the necessary skills to run such a venue with the extension. To evidence that his application was reasonable and compatible with the area the Dar Marrakesh is situated. In addition that the extension was in line an in accordance with the Licensing Objectives as contained in the Licensing Act 2003.

I agreed to attend the premises on two separate dates both Friday evenings namely the 13th of March 2015 and the 10th of April 2015. The times of my observation both of the premises and surrounding area were between the hours of 6pm and midnight.

Mr Derissy has applied to extend his hours of opening to midnight on Monday to Thursday and 2am on Friday and Saturday for Late Night Refreshment and back to midnight on a Sunday. He further wishes to remove the condition that the Garden Area be cleared by 11pm. Lastly he wishes to have removed the condition that toughened Glasses be used.

The Civil Procedures Rules Para 35 governs the appointment of "Expert Witnesses" and "Professional Assessors.

The principle duty of such witnesses is to provide accurate and truthful information to the hearing or Court proceedings. I am fully aware of this fact and made that clear to Mr Derissy before agreeing to undertake a review.

QUALIFICATIONS

My professional background is evidenced in Exhibit DSD1.

In summary I have 47 years policing and Security experience, I am the former Operational Head of Scotland Yard's Royalty Protection Command. Prior to that appointment I was Head of Operations for West London and also Commanded West London's Territorial Support Group. In my Police career I had extensive knowledge of Licensing and tackling violence and disorder in many different areas of London and the United Kingdom.

Since retirement I have had wide international experience in a range of policing, security and related matters. Licensing has continued to be an area where my advice and knowledge has been sought.

I am a Visiting Lecturer at Cardiff University and have been invited to apply for elevation to Professor, lecturing in Ethical Leadership and Motivation.

I am a regular contributor in the media speaking on Television, Radio and writing articles in National Newspapers. My subject areas include The British Royal Family, Policing, and Child Protection. I have recently retired as the Ambassador for the National Children's Charity Kidscape.

METHODOLOGY

On Friday the 13th of March 2015 at 6pm I attended the Dar Marrakesh in Edgware Rd W2 to meet Mr Zak Derissy, his staff and to assess the premises, location facilities and his customers. In addition during the course of the evening I visited surrounding streets and the other local licensed premises in an attempt to gain the wider picture.

The premises are situated on the busy Edgware Road and a narrow side road Boscobel Street runs along the side of the pub. This is an incredibly busy arterial two

way road into the area and provides access to literally hundreds of flats and other accommodation and facilities that are based in the neighbourhood. This road is the first right hand turn off the Edgware Road after the flyover and is very busy / in constant use throughout the day and night.

The purpose of this visit was to examine as thoroughly as possible whether the premises was complying with the Licensing Act 2003 and whether the application for extended hours was reasonable and proportionate to the management and the activity that the premises facilitated.

I examined the criteria as it would affect the four key elements central to any licensed premises. Namely:

- The Prevention of Crime and Disorder.
- Prevention of Public Nuisance.
- Public Safety.
- Protection of Children from Harm.

I thoroughly examined all areas of the public house and the "garden area" where the vast majority of the customers were, mainly smoking from Shisha pipes. I would estimate that at 6.30pm there were approximately 60 people in the garden area and about 10 people in the Pub section. There was a convivial attitude and without exception everyone was well behaved. The majority were not drinking alcohol but non alcoholic drinks. It was noticeable that over half of the customers were women.

I understand that a minor variation of the licence has recently been granted so as to permit the new canopy in the garden to remain in situ so I am satisfied that this canopy meets the requirements of the smoke free regulations. I gather that the style and size of canopy was agreed with Francis Keegan, Westminster Licensing Inspector before it was put up.

The level of noise and music inside the premises was reasonable and I went outside at least ten times during the course of the evening and night; the noise could hardly be heard even on the pavement right outside. Standing some 20 yards from the garden, I could not hear any voices from the garden, though this was possibly due to the constant traffic.

What was apparent was the noise of traffic, buses and the frequent sirens from emergency services. Boscobel Street is very busy (as is the Edgware Road) and the volume of traffic coming to and stopping outside a Pizza Takeaway and a very Popular Turkish Restaurant is considerable. The noise and traffic remained throughout the time that I was there – it was the same at midnight as it was at 6 p.m - I observed the premises from inside and outside for over 6 hours.

The customers without exception were well behaved. I saw some customers leaving by taxi and minicab, others must have been using the tube or buses. The end of the evening was well supervised and there was nothing to give rise to complaint. On both nights, the garden area was clear by 10,45pm. the pub area by 11.15pm. During the course of the evening I examined the local area by physically walking and entering various Licensed Premises. This included two public houses and several restaurants. All were serving alcohol in either pint glasses or with other glass receptacles. It was noticeable how many groups of young men were congregating near take away premises. Some were noisy and intimidating in both presence and attitude but I did not see anybody leave Dar Marrakesh and go to these places, nor did I see any of these people enter Dar Marrakesh.

PREMISES INSPECTION

In order to establish effective" Premises Supervision" I carried out an inspection in the presence of the DPS Mr Moulay Derissy of the following areas of importance to satisfy myself of the level of management and supervision needed if the various variations were to be granted.

I also reviewed the current premises licence to satisfy myself that all the conditions on the licence were being adhered to.

Key Areas

- 1. Location and Supervision of Entrance and Exits, fire escapes, security of doors. Security of Premises.
- 2. Camera Location and quality of images. The number of trained staff. Duration of recordkeeping.

- 3. Staff Numbers, supervision of Bar and Garden area.
- 4. Door supervision. Numbers and search procedure.
- 5. Dress Code ,Age Policy.
- 6. Drug Awareness, Drug Policy. Drug posters. Toilet checks.
- 7. Customer Profile,
- 8. Knowledge of Licensing Act.,
- 9. Entry and Dispersal policy. Age Policy Over 21.
- 10. Notices re Customers respecting Neighbours.
- 11. Number of Incidents and Crimes reported.
- 12. Liaison Policy with Neighbours.
- 13. Police Liaison number of visits
- 14. Staff Training and record keeping. Occurrence register.
- 15. Complaints Register / Customer neighbourhood complaints policy.
- 16. Sound Proofing of Garden Area.
- 17. Fire and Hazard Training and Check
- 18 Glass and bottle collection
- 19. Bar Supervision. Management Structure.
- 20. Check of Premises licence conditions.
- 21. Smoke free area compliant with smoke free regs.

On this the first visit I carried out a thorough examination of all aspects pertaining to this application by spending six hours both inside and outside the premises. I paid particular attention to the alleged noise and the degree of supervision and capability of the staff and family who run the establishment.

The main area of business is without doubt carried out in the area described as the "Garden" where fairly affluent people smoke and drink non alcoholic drinks. The premises also sells food and appears to do a good trade in this area. The bar area is only a fraction of the business and a ratio of 15% in the Bar compared to 85% in the Garden on the night I was there.

In view of the pending application, I made several recommendations during my visit, as follows:

- Door supervisors should wear florescent yellow jackets and patrol outside when customers are leaving and during extended hours if granted, Customers leaving should only leave by the Edgware Rd entrance. Right hand side.
- Large Notice boards at exit points reminding customers to respect neighbours and keep quiet when leaving.
- That music is turned off every night at 23.30 hours.
- Enhanced training to all staff in the key areas of the Licensing Act. Training to be recorded. Training Manual to be established.
- A full 'Occurrence Book' is taken into use with all relevant factors recorded and signed off daily.
- Greater use of posters in toilets re potential drug misuse. Drugs are not perceived to be problem but preventative tactics are always wise in all licensed premises, even well run ones.
- Dispersal policy to be drawn up and adhered to as part of a Management Plan.
- No children to be allowed in the garden after 18.00 hours.

This visit terminated just after midnight I remained in the area overnight on the Edgware Road. This arterial Road seems to remain busy pretty much all of the time. I visited several local premises and a number of food outlets. One premises the Lord High Admiral had a number of drunken customers inside and outside. The level of reported crime at Dar Marrakesh is by any standards extremely low which is in my view testimony and evidence of the management style and close supervision.

DAR MARRAKESH SECOND VISIT

On Friday the 10th of April I returned to the premises arriving at 6.30pm, the visit was unannounced as far as the staff were concerned. I stayed in the vicinity until midnight again repeating my recognisance of the premises and the local environment.

Both the Bar area and the garden area were full. It was an extraordinarily warm evening for the time of year and the area was full inside. Also the garden has the benefit of patio heaters. The Edgware Road and Boscobel Street was also busy with pedestrian and vehicle traffic. The noise from the garden was listened to on at least six different occasions during the night. It was not in any way excessive or likely to cause a nuisance to anyone.

On this visit I again interviewed the DPS Mr Derissy (a former Special constable in the Metropolitan Police) this time to carry out a structured thematic check. I used a document entitled Licensed Premises "Good Practice Guidelines" this document provides a RISK and Good Measures guide in respect of the Four Licensing Objectives.

From the answers given, and my observation I am again satisfied the Management of these premises are in good hands and that Mr Derissy and his team are now fully conversant with the Licensing Objectives, the Law and the application of common sense and responsibility necessary to ensure good order.

The Dar Marrakesh customers were well behaved with large numbers of women arriving and departing. All left quietly without any disturbance. I observed two customers getting into a car parked outside, the rest left on foot or got into taxis in the Edgware Road.

This premises is more akin to a restaurant with a bar area ,the main emphasis of customers is on food and smoking not drinking which eases the problems possibly anticipated as customers can be advised quietly but firmly of the need to leave quietly.

The issue of parking is not a big issue for the Dar Marrakesh as most customers did not arrive by car. However there are numerous other food outlets and restaurants where customers do leave cars in surrounding streets and may cause problems. However Hatton Street during my visit was full of residential parking, There is a restriction of parking until 10pm for non residents.

Boscobel Street does have some restricted parking, it is narrow and remains extremely noisy throughout the evening, Many, many vehicles come and try and park

near the Diarbakirlal Turkish Restaurant and this does cause problems as does the Pizza Take Away which allegedly had been operating until 4am until recent Westminster Council Action.

CONCLUSION

On the evidence I have seen and with the actions I have advised, I am confident that the extension of hours can be allowed providing the assurances that I have received can be delivered and maintained. I am also confident that allowing non-toughened glasses to be used will not be a problem. I now understand that the police have withdrawn their objection to this part of the application on the basis that two SIA doorstaff are employed on Fridays and Saturdays after 20.00 hours, which is sensible. In addition the premises will have one SIA doorstaff present from 20.00 hours on Sunday to Thursday inclusive. There is no application to extend the hours for alcohol and the current condition re: toughened glasses as drafted is almost certainly unenforceable in any event.

Some of the allegations made by residents do lack credibility particularity the allegation of crime being enhanced i.e. the danger to employees leaving late. The presence of SIA doorstaff should make the area safer for employees and residents alike.

I am particularly impressed with the condition offered by the applicants as follows: "No use of interior of premises by patrons after 23.30 hours Sunday to Thursday and 00.00 hours on Fridays and Saturdays, save for access and egress of the premises and to use the toilets."

This condition in conjunction with the condition requiring patrons to use the door leading on to Edgware Road means that all patrons departing after 23.30 hours have to go through the inside of the pub where no licensable activities are taking place before they leave the premises. This means that staff can speak to departing customers before they leave the premises in order to remind them of the need to be quiet outside. It also provides a quiet area where people can wait for taxis. The fact

that the exit door is on the corner of Edgware Road and Boscobel Street means that one of the SIA staff can be placed in a position outside where he or she can see down both roads to check that customers are leaving quietly, though from what I could see almost all customers will leave via Edgware Road.

If the Management continue to maintain their current high standards, then I am confident that with appropriate conditions and continued support they can be trusted to keep good order and provide a facility people enjoy without affecting the peace and tranquillity of others.

DAR MARRAKESH LICENSING MANAGEMENT PLAN / DISPERSAL POLICY

Premises Licence:

This document is to be read in conjunction with the current premises licence. All staff should familiarise themselves with the licence and all of the conditions on it.

Other Policies:

Staff should also familiarise themselves with regard to our health and safety policies, fire safety risk assessments, first aid policy, pre-opening check-list, "Good Practice Guidelines", drug policies, CCTV usage, e.t.c.

OTHER KEY POINTS:

Admission:

All customers to be smartly dressed, no entry to under 18's after 18.00 hours.

Security:

After 20.00 hours, one SIA doorstaff to be engaged Sunday to Thursday and two SIA doorstaff to be engaged after that time on Fridays and Saturdays.

Drugs:

We operate a zero tolerance policy with regard to all forms of illegal drugs.

Challenge 25:

We operate Challenge 25 which means that anyone who looks as if they could be under 25 years old must provide suitable ID if they want to buy alcohol.

Occurrence Book:

This is to be filled in daily whether or not anything of note needs to be recorded.

Noise Nuisance:

Our licence is our business. Any risk of noise nuisance of any kind but particularly from patrons must be avoided at all costs.

<u>All staff to be vigilant at all times</u> regarding customer noise in the garden. Anybody making too much noise to be asked to leave immediately.

Notices to be placed in the garden asking patrons to be quiet.

No alcohol to be served in the garden (or elsewhere) after 23.30 Monday to Thursday, 22.30 on Sundays or midnight on Fridays or Saturdays.

Recorded music to be turned off at 23.30 on all evenings at the latest.

To ensure that customers leave in an orderly and quiet fashion the following policy will be adhered to:

Dispersal Policy:

- 1. At least one SIA door supervisor will be located at the Edgware Road entrance in order to ensure customers departing via either Edgware Road or Boscobel Street are supervised at all times after 8 p.m.
- 2. Customers will be encouraged to leave via taxi or mini-cab which will be pre-booked inside the premises. Once the taxi arrives, the customers will be escorted from the premises to the taxis. Taxis and minicabs to collect from Edgware Road not Boscobel Street and not to use horn on arrival liasion with local firms. If black cabs are used, staff to hail them.
- 3. Door supervisors to wear yellow florescent jackets to identify themselves as Dar Marrakesh security.
- 4. Large notices to be placed near the exit reminding customers of the need to leave quietly.
- 5. Customers waiting for taxis who have finished their refreshment in the garden to wait inside the premises.
- 6. Staff to be aware of nightbus times, stops and routes the N16 departs every 20 minutes. Wherever possible, staff will use the London Transport text service to advise customers when buses are coming so that they are waiting at the stop for the minimum amount of time.

STATEMENT OF ZAKARIAH DERISSY:

I am the owner of the business known as "Dar Marrakesh" and the Premises Licence Holder.

I am 58 years old and originally from Morocco. I have had a varied business career and took over the pub known as the Portman Arms on the Edgware Road a few years ago. At that time, it was an Irish pub but unfortunately its trade was falling away and there had been problems at the premises to the extent that the police saw fit to ask for a condition requiring toughened glasses to be used at the premises.

I realised that the venue was never going to be a successful business as a normal pub and set about making it into an upmarket Moroccan bar / restaurant with shisha smoking in the garden. This was clearly the right move as it has become a popular venue with regular repeat customers - we know most of our customers, many of whom come from the locality. Some are Moroccan but many are local English people who enjoy our different cuisine and like to try smoking shisha.

I brought my two sons (one of who was a Special Constable) into the business and Moulay obtained a personal licence and became the DPS.

Generally, we did not attract complaints or problems with the licensing authorities.

Some time last year, a new licensing inspector, Francis Keegan took over. He pointed out his opinion that we needed a new smoking canopy in order to make it compliant with the smoke free regulations. The previous inspector had never mentioned this before but I realised that the only way forward was to work with Mr.Keegan rather than against him and therefore I arranged for a new canopy to be put up in accordance with the plan he had drawn out.

Some of our customers complained at having to drink from toughened glasses - we like to serve good wine and it does not taste the same from toughened glasses as from normal glasses; the same applies to hot drinks such as mint tea. We simply do not have problems with violence at the premises and in any event we employ doorstaff who would take care of any problems in the highly unlikely event of any problems. Therefore we have applied to be able to use non-toughened glasses and I am pleased to see that the police have agreed to this.

Our customers also asked to be able to stay in the garden a little later, especially on Friday and Saturday evenings. This would help our business very considerably. I realised that this would take careful management but given the fact that we are in a very noisy area due to the traffic, did not see that this would be a problem. I recognised the need to engage the services of accoustic consultants and a top security / licensing professional as I was anxious to ensure that we did everything absolutely correctly.

I notice that nobody living in the large block of flats behind the garden or to the side of us on Edgware Road has objected to the application.

We have asked nearby neighbours for letters of support for our application and I am very pleased to say that they have provided them.

I would be happy to show the committee my food and shisha menus.

DAR MARRAKESH LICENSING MANAGEMENT PLAN / DISPERSAL POLICY

Premises Licence:

This document is to be read in conjunction with the current premises licence. All staff should familiarise themselves with the licence and all of the conditions on it.

Other Policies:

Staff should also familiarise themselves with regard to our health and safety policies, fire safety risk assessments, first aid policy, pre-opening check-list, "Good Practice Guidelines", drug policies, CCTV usage, e.t.c.

OTHER KEY POINTS:

Admission:

All customers to be smartly dressed, no entry to under 18's after 18.00 hours.

Security:

After 20.00 hours, one SIA doorstaff to be engaged Sunday to Thursday and two SIA doorstaff to be engaged after that time on Fridays and Saturdays.

Drugs:

We operate a zero tolerance policy with regard to all forms of illegal drugs.

Challenge 25:

We operate Challenge 25 which means that anyone who looks as if they could be under 25 years old must provide suitable ID if they want to buy alcohol.

Occurrence Book:

This is to be filled in daily whether or not anything of note needs to be recorded.

Noise Nuisance:

Our licence is our business. Any risk of noise nuisance of any kind but particularly from patrons must be avoided at all costs.

All staff to be vigilant at all times regarding customer noise in the garden. Anybody making too much noise to be asked to leave immediately.

Notices to be placed in the garden asking patrons to be quiet.

No alcohol to be served in the garden (or elsewhere) after 23.30 Monday to Thursday, 22.30 on Sundays or midnight on Fridays or Saturdays.

Recorded music to be turned off at 23.30 on all evenings at the latest.

To ensure that customers leave in an orderly and quiet fashion the following policy will be adhered to:

Dispersal Policy:

- 1. At least one SIA door supervisor will be located at the Edgware Road entrance in order to ensure customers departing via either Edgware Road or Boscobel Street are supervised at all times after 8 p.m.
- 2. Customers will be encouraged to leave via taxi or mini-cab which will be pre-booked inside the premises. Once the taxi arrives, the customers will be escorted from the premises to the taxis. Taxis and minicabs to collect from Edgware Road not Boscobel Street and not to use horn on arrival liasion with local firms. If black cabs are used, staff to hail them.
- 3. Door supervisors to wear yellow florescent jackets to identify themselves as Dar Marrakesh security.
- 4. Large notices to be placed near the exit reminding customers of the need to leave quietly.
- 5. Customers waiting for taxis who have finished their refreshment in the garden to wait inside the premises.
- 6. Staff to be aware of nightbus times, stops and routes the N16 departs every 20 minutes. Wherever possible, staff will use the London Transport text service to advise customers when buses are coming so that they are waiting at the stop for the minimum amount of time.
- 7. Staff to be aware of latest Edgware Road trains -

District 00.20 West (East last stop).

8. Music turned off at 23.30 hours every night.

- 13. Resident's hotline telephone number to be manned throughout the evening hours of operation.
- 14. Access and egress by patrons to be only through the Edgware Road doorway save in the case of emergency.

STATEMENT OF MOULAY DERISSY:

I am the son of the owner of the business known as "Dar Marrakesh" and the DPS. My brother also works in this family business.

I repeat and endorse everything which my father, Zakariah, says in his statement.

I have been a Special Constable and therefore believe that I am well placed to understand the concerns of the police and licensing authority.

With regard to the "toughened glasses" condition, in fact the last time our licence was printed, this condition was somehow missed off and we have been advised that it would be difficult to enforce against us as it is badly drafted but we still recognise the need to do things properly and therefore have applied to have it removed. I am pleased that the police have endorsed that application. They have asked us to have two SIA staff on duty from 8 p.m. on Fridays and Saturdays and we are happy to comply with that request. We also have an SIA staff member on duty from 8 p.m. on other nights of the week.

Since we took over the premises (which used to be known as the Portman Arms) a few years ago, we have turned it into an upmarket Moroccan bar restaurant with shisha smoking. Shisha smoking is the one thing which makes our business unique and in fact makes it viable; we spend a small fortune on gas for patio heaters every year but it is worth it as that is what our customers want. However trade is not very easy and there is a real demand for customers to be able to stay in the garden a little later into the evening.

We do believe that we have turned a rough pub into a desirable venue in the locality and this is borne out by the low number of residential objections we have had to the application and the support we have received for it.

Together with Dai Davies, I have been involved in developing our management and dispersal policy. I recognise that if this application is to succeed, it is paramount that there are no noise nuisance problems from the garden or from departing patrons.

Fortunately we do attract a great deal of regular customers. They are generally relatively affluent and well behaved people who do not want to cause trouble. Many are local. We are already vigilant about the risk of noise nuisance and if we are able to operate outside to a later hour, no doubt it will be doubly important to ensure that neighbours are not disturbed by people in our garden. Although we are in a noisy area, we will continue to operate regular checks outside the garden wall and upstairs throughout the evening to ensure that noise in the garden is not a nuisance to others.

As it happens, shisha smoking is a relatively quiet affair in any event. Our prices are high and people like to savour their smoking, whilst enjoying soft drinks and food. The absence of alcohol during the later hours is important as people who are not drinking alcohol are so much less likely to cause disturbance, not that our clientele are the sort of people who would anyway.

Since lodging the licence variation application, I have decided to offer some further conditions:

1. Two SIA staff to be engaged at the premises after 8 p.m. on Fridays and Saturdays and one SIA staff to be engaged at the premises after 8 p.m. Sunday to Thursday inclusive.

- 2. Recorded music to be turned off at 23.30 hours.
- 3. To operate a dispersal policy as part of the management plan.
- 4. No children in the garden after 18.00 hours.

I may wish to expand on this statement at the hearing.

I very much hope that the committee will see fit to grant our application.

 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- 7. The responsible person must ensure that—
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

- 8. (i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
 - (ii) For the purposes of the condition set out in paragraph 8(i) above -
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
 - (b) "permitted price" is the price found by applying the formula -

P = D+(DxV)

Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -

- (i) the holder of the premises licence,
- the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- (iii) Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (iv) (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Conditions which reproduce the effect of any restriction imposed on the use of the premises by specified enactment

9. The terminal hour for late night refreshment on New Year's Eve is extended to 05:00 on New Year's Day.

Annex 2 – Conditions consistent with the operating Schedule

- 10. There shall be no entry to the premises one hour before the end of all licensable activities.
- No adult entertainment paid for by the company of a nude physical nature shall be permitted on the premises.
- 12. There shall be no promotions that encourage illegal, irresponsible or immoderate consumption of alcohol.
- 13. Free drinking water shall be available to all customers.
- 14. Notices shall be displayed around the premises asking patrons to leave quietly.
- 15. Deliveries shall be conducted during daytime to control noise nuisance.

Annex 3 – Conditions attached after a hearing by the licensing authority

- 16. Alcohol may be sold or supplied:
 - (a) On Monday to Thursday, 10:00 to 23:30
 - (b) On Friday and Saturday, 10:00 to 00:00
 - (c) On Sundays, 12:00 to 22:30
 - On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).

NOTE - The above restrictions do not prohibit:

- (a) during the first twenty minutes after the above hours the consumption of the alcohol on the premises;
- (b) during the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
- (c) during the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking table meals there if the alcohol was supplied for consumption as ancillary to the meals;
- the sale or supply of alcohol to or the consumption of alcohol by any person residing in the licensed premises;
- (e) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- (f) the sale of alcohol to a trader or registered club for the purposes of the trade or club:
- (g) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces.


In this condition, any reference to a person residing in the premises shall be construed as including a person not residing there but carrying on or in charge of the business on the premises.

- 17. All persons under 18 years of age to be off the premises by 21:00 hours unless accompanied by an adult and partaking in a table meal.
- 18. The premises will maintain a comprehensive CCTV system that ensures all areas of the licensed premises are monitored including all entry and exit points, the street environment and which enable frontal identification of every person entering in any light condition. All cameras shall continually record whilst the premises are open to the public and the video recordings shall be kept available for a minimum of 31 days with time and date stamping.
 - (i) Tape recordings shall be made available to an authorised officer or a police officer together with facilities for viewing.
 - (ii) The recordings for the preceding two days shall be made available immediately on request. Recordings outside this period shall be made available on 24 hours notice (subject to the Data Protection Act 1998).
- 19. Noise and vibration will not be allowed to emanate from the premises so as to cause a nuisance to nearby property.
- 20. The external doors and windows shall be kept closed after 23:00 except for immediate access and egress of persons.
- 21. All waste is to be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times.

- 22. No rubbish including bottles will be moved, removed or placed outside between 23:00 hours and 07:00 hours.
- 23. A sound limiting device shall be located in a separate and remote lockable cabin form the volume control and must be fitted to the musical amplification system to be set at a level determined by and to the satisfaction of an authorised officer of the environmental health services community protection department to ensure that no noise nuisance is caused to local residents. The operational panel of the noise limiter shall then be secured to the satisfaction of an officer from the environmental health service. The keys securing the noise limiter cabinet shall be held by the applicant only, and shall not be accessed by any other person. The limiter shall not be altered without prior agreement with the environmental health service.
- 24. No alteration or any modification to any existing sound system(s) should be effected without prior knowledge of an authorised officer of the environmental health services.
- 25. There are to be no more than two live musicians at any one time.
- 26. The beer garden is to be cleared of patrons by 23:00.
- 27. The inner door and all windows at the premises are to be kept closed at all times when licensable activities are taking place.
- 28. When a customer chooses to pay by credit/debit card, he/she shall be presented with an itemised bill upon final payment showing details of all drinks and food purchased.

Until very recently, the pub normally took an hour or more after official closing time to empty and even those customers who left relatively quietly were causing sufficient disturbance until after 12.00, 1.00 or 2.00 am to wake people up. Even after the doors were shut, gangs of noisy, sometimes rowdy people would arrive, particularly on Friday and Saturday nights, knocking on the doors to try and get access, sometimes with success. My lodger, Ms Piancek complained to both the Police and the Noise Team on different issues several times but as most of these individual nuisances are over within twenty minutes, this is to little effect. Finally, the Dar Marrakesh staff have habitually taken the empties out at these times, against a condition of their licence and this is also noisy.

Though I accept the application does not include an extension of alcohol availability and there has been a greater observance of the existing licence since this application has been made, I contend that the Dar Marrakesh practice of consideration for residents has not been impressive generally and that in any case, even moderate behaviour from its customers would still cause a nuisance at these later times. Apart from my immediate neighbours, the pub and street is overlooked by Mole and Westmacott houses, both five-storey blocks occupied mostly by families, many with young children who will be similarly disturbed. 10 (iii) which provide food in the form of substantial table meals that are prepared on the premises and consumed at the table using non disposable crockery.

1. Relevant representations

- 1.1 The Environmental Health Service made an adverse representation against this application however following discussions with the applicant, Environmental Health have withdrawn their representation.
- 1.2 The Metropolitan Police service has made an adverse representation against this application as it is their belief that this amendment would undermine the licensing objectives.

2. Policies Applicable

2.1 The following policies within the City Of Westminster Statement of Licensing Policy apply:

Policy HRS1 applies:

- (i) Applications for hours within the core hours set out below in this policy will generally be granted, subject to not being contrary to other policies in the Statement of Licensing Policy.
- (ii) Applications for hours outside the core hours set out below in this policy will be considered on their merits, subject to other relevant policies.

Policy RNT2 applies:

Applications will be granted subject to other policies and subject to the relevant criteria in Policies CD1, PS1, PN1 and CH1, provided it can be demonstrated that they will not add to cumulative impact in the Stress Areas.

Policy FFP2 applies:

It is the Licensing Authority's policy to refuse applications in the Stress Areas, other than applications to vary hours within the Core Hours under Policy HRS1.

Policy STR1 applies:

- (i) It is the Licensing Authority's policy to refuse applications in the Stress Areas for: pubs and bars; fast food premises, and premises offering facilities for music and dancing; other than applications to vary hours within the Core Hours under Policy HRS1.
- (ii) Applications for other licensable activities in the Stress Areas will be subject to other policies and must demonstrate that they will not add to cumulative impact in the Stress Areas.

3. Summary

- 3.1 The Licensing Sub-committee may refuse, grant in full or grant in part this proposal, having taken into account the representations received and Westminster's Statement of Licensing Policy. The decision taken should promote the licensing objectives of:
 - prevention of public nuisance,
 - prevention of crime & disorder.
 - public safety and
 - protection of children from harm.
- 3.2 Where the committee is minded to grant the licence it will be granted subject to the mandatory conditions and conditions consistent with the operating schedule modified to such extent as the authority considers appropriate for the promotion of the licensing objectives detailed in Appendix D to this report.

Conditions: On Current Licence -

Annex 1 – Mandatory conditions

- 1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
- 2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
- 3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);

- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- 7. The responsible person must ensure that—
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

- 8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 8(ii) For the purposes of the condition set out in paragraph 8(i) above -
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979:
 - (b) "permitted price" is the price found by applying the formula -

P = D + (DxV)

Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol:
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 8(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

- 8(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 – Conditions consistent with the operating Schedule

10. The premises shall only operate as a restaurant (i) in which customers are shown to their table, (ii) where the supply of alcohol is by waiter or waitress service only, (iii) which provide food in the form of substantial table meals that are prepared on the premises and are served and consumed at the table using non disposable crockery, (iv) which do not provide any take away service of food or drink for immediate consumption, (v) which do not provide any take away service of food or drink after 23.00, and (vi) where alcohol shall not be sold, supplied, or consumed on the premises otherwise than to persons who are seated in the premises and bona fide taking substantial table meals there and provided always that the consumption of alcohol by such persons is ancillary to taking such meals.

Notwithstanding this condition (10) customers are permitted to take from the premises part consumed and resealed bottles of wine supplied ancillary to their meal and (b) alcohol may be supplied to and/or consumed prior to their meal by customers in the basement up to a maximum, at any one time, of 16 persons dining at the premises

- 12. After 22:00 hours the entrance door shall be kept closed except for immediate access and egress of persons or at anytime that regulated entertainment is provided.
- 13. A challenge 21 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 14. Clearly legible notices shall be displayed at all exits from the premises requesting patrons to respect the needs of local residents and to leave the premises and area quietly.
- 15. Patrons permitted to temporarily leave and then re-enter the premises, eg to smoke, shall not be permitted to take drinks or glass containers with them.

- 16. No rubbish, including bottles, shall be moved, removed or placed in outside areas between 23.00 and 08.00 hours.
- 17. No deliveries to the premises shall take place between 23.00 and 08.00 hours.
- 18. During the hours of operation of the premises, the licence holder shall ensure sufficient measures are in place to remove and prevent litter or waste arising or accumulating from customers in the area immediately outside the premises, and that this area shall be swept and or washed, and litter and sweepings collected and stored in accordance with the approved refuse storage arrangements by close of business.
- 19. There shall be no striptease or nudity, and all persons shall be decently attired at all times, except when the premises are operating under the authority of a Sexual Entertainment Venue licence.
- 20. Substantial food and non-intoxicating beverages, including drinking water, shall be available in all parts of the Premises where alcohol is sold or supplied for consumption on the Premises.
- 21. A record shall be kept detailing all refused sales of alcohol. The record shall include the date and time of the refused sale and the name of the member of staff who refused the sale. The record shall be available for inspection at the Premises by the police or an authorised officer of the City Council at all times whilst the Premises are open.
- 22. Children under the age of 14 will not be permitted to remain in the premises after 21:00 hours
- 23. No noise shall emanate from the Premises nor vibration be transmitted through the structure of the Premises which gives rise to a public nuisance:
- 24. Loudspeakers shall not be located in the entrance lobby or outside the building of which the Premises form part.
- 25. Hours for licensable activities and opening may be extended from the end of trade on New Year's Eve to the beginning of trade on New Year's Day.
- 26. The variation of the Premises Licence 14/03927/LIPN to include the following works:
 - ground floor: minor changes to back -of-house areas
 - installation of counter/till area

 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- 7. The responsible person must ensure that—
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

- 8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 8(ii) For the purposes of the condition set out in paragraph 8(i) above -
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979:

- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
 - (i) the holder of the premises licence,

- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and



1. SUMMARY OF APPLICATION

- 1.1 An application submitted by the Licensing Inspectorate for a review of the premises licence for Norris News, 115 Lupus Street, London, SW1V 3EN, was received on 17 February 2015 on the grounds of the prevention of crime and disorder and the protection of children from harm (see Annex A1).
- 1.2 Guidance issued under section 182 of the Licensing Act 2003 (para 11.2) states that at any stage following the grant of a premises licence, a responsible authority, such as the Police or the Environmental Health Service, or any other person who can seek a review, may ask the Licensing Authority to review the premises licence because of a matter arising at the premises in connection with any of the four licensing objectives.
- 1.3 As such, in accordance with section 52(2) of the above-mentioned Act, the Licensing Authority must hold a hearing to consider the application and any relevant representations.
- 1.4 The premises currently benefits from a premises licence (13/05276/LIPVM, attached at **Annex A2**) that permits:

Sale by retail of alcohol (off sales)

Monday to Saturday: 08:00 to 23:00

Sunday: 10:00 to 22:30

- 1.5 These review proceedings are brought under the licensing objectives on the grounds of the prevention of crime and disorder and the protection of children from harm. A history of visits, observations and complaints has been provided by the applicant (see Appendix 4 to Annex A1).
- 1.6 On 13 November 2014, Customs and Excise seized 886.56 litres of beer and 36 litres of wine from the premises on the basis that no excise duty had been paid on the goods. This is an offence under s170 Customs and Excise Management Act 1979 and s144 Licensing Act 2003. This incident, in conjunction with other recent historical breaches, leads the applicant to believe that the premises are unable to promote the licensing objectives (see Annex A1).
- 1.7 The named owner of the business at the time of the visit by Customs and Excise on 13 November 2014 was Mr Shusilkumar Bhavsar (see Annex A1). However, the holder of the Premises Licence and Designated Premises Supervisor is Mr Prashant Patel (see Annex A2).

1.8 On 8 December 2014, a letter from Mr Gareth Cleary of the Licensing Inspectorate was sent to Mr Shusilkumar Bhavsar regarding the Customs and Excise visit and inviting Mr Bhavsar to an interview under caution or to submit a response in writing. On 20 January 2015, similar letters were sent to Mr Prashant Patel. In subsequent emails dated 2 January 2015 and 5 February 2015, Mr Bhavsar accepts liability for the incident (see Appendix 2 to Annex A1). No response has been provided to the letters of Mr Cleary from Mr Patel.

2. REPRESENTATIONS:

2.1 The Environmental Health Service, as a responsible authority, supports the review application on the grounds of the prevention of crime and disorder and the protection of children from harm (see **Annex B**).

3. OPTIONS:

- 3.1 The Authority must, having regard to the application and the representations, take such steps (if any), as it considers appropriate for the promotion of the licensing objectives. The steps are:
 - (a) to modify the conditions of the licence;
 - (b) to exclude a licensable activity from the scope of the licence;
 - (c) to remove the designated premises supervisor;
 - (d) to suspend the licence for a period not exceeding three months;
 - (e) to revoke the licence;
 - and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition added.
- 3.2 In accordance with section 52(6) of the 2003 Act, if the authority takes measures to modify conditions or exclude licensable activities from the licence, it may stipulate that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.
- 3.3 The licensing authority's determination of this application does not have effect until the 21 day appeal period has expired or if the decision is appealed the date the appeal is determined and / or disposed of.

On the 13 th November 2014, during an operation involving Customs and Excise, substantial quantities of alcohol were seized from the premises when it became apparent that no 'Excise duty' had been paid on the goods. These are offences under S.170 Customs and Excise Management Act 1979 and S. 144 Licensing Act 2003. The named owner of the business at the time of visit by Customs and Excise was given as a Mr Shusilkumar Bhavsar.
The incident taken together with recent historical breaches indicate that the premises are unable to promote the Licensing Objective of;-
1/ Crime and Disorder 2/ The protection of children from harm

Please provide as much information as possible to support the application (please read guidance note 3)

The premise operates predominantly as an off licence and is currently licensed for Sale by retail of alcohol (Monday to Saturday 0800-2300hrs and Sunday 1000-2230hrs). Mr Prashant Patel is both the Designated Premises Supervisor and the holder of the premises licence and has held these positions since 30th January 2012.

(See Appendix 1 for a copy of the current Premises Licence and photographs of the premises)

On 13th November 2014, a visit was carried out by Officers of HMRC to the premise under the authority of section 112 of the Customs & Excise Management Act. The owner of the shop, Mr Shusilkumar Bhavsar, who was present throughout the visit was asked to provide purchase records in respect of the canned beers and wine in the shop to demonstrate that the UK duty had been paid. Mr Bhavsar admitted that some of the wine and most of the canned beers on the premises had been purchased without an invoice. This admission led Customs & Excise Officers to believe, on the balance of probabilities that UK duty had not been paid on the alcohol in question. As a result of this admission the decision was taken to seize the alcohol detailed below, pursuant to section 139 of the Customs & Excise Management Act 1979 as it was liable to forfeiture on the basis that, on the balance of probabilities, the UK excise duty had not been paid. In total the following quantities were seized;

886.56 litres of beer 36 litres of wine

The duty figures of the seized stock amounted to £1224.55, including VAT.

Mr Bhavsar was issued with a seizure information notice, a warning letter and a booklet explaining his right to appeal the seizure. To date, Customs & Excise are not aware of any appeal against the seizure. The relevant overarching criminal offence is one of being knowingly concerned in the fraudulent evasion of excise duty contrary to section 170 of the Customs & Excise Management Act. In addition it is also an offence contrary to S. 144 of the Licensing Act 2003 for the Designated Premises Supervisor and/or holder of a Premises Licence to 'knowingly keep on licensed premises any goods without payment of duty'.

To date, there is no evidence that a transfer of the Designated Premises Supervisor or the holder of the premises licence has been applied for or been submitted to Westminster City Council therefore legal letters were sent both to Mr Shusilkumar Bhavsar who stated that he was the owner at the time of offence and also Mr Prashant Patel who is the current holder and Designated Premises Supervisor of the premises licence.

Legal letters have been sent to both Mr Bhavsar and Mr Patel with regards to the seizure of alcohol by Customs & Excise. To date, only Mr Bhavsar has replied by email and phone however Mr Patel has failed to respond to the letter.

In the statutory "Guidance issued under section 182 of the Licensing Act 2003" (under the heading of "Reviews arising in connection with crime") it states:

- 11.27 There is certain criminal activity that may arise in connection with licensed premises which should be treated particularly seriously. These are the use of the licensed premises:
 - For the sale of smuggled tobacco and alcohol.
- 11.28 It is envisaged that licensing authorities, the police and other enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence even in the first instance should be seriously considered.

Since the premises licence was issued to the business back in February 2012, there have been a history of breaches relating to Licensing Act 2003 and non-compliance of premises licence conditions and specifically the sale of alcohol to two under 18 year olds (contrary to S146 of the Licensing Act 2003).

- 5. The premises shall install and maintain a CCTV system as per the minimum requirements of a Metropolitan Police Crime Prevention Officer. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises are open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available with the absolute minimum of delay upon the request of Police or authorised officer throughout the preceding 31 day period.
- 6. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member shall be able to show Police recent data or footage with the absolute minimum of delay when requested
- 7. Outside of the hours authorised for the sale of alcohol, all alcohol within the trading area is to be secured behind locked grills, locked screens or locked cabinet doors so as to prevent access to the alcohol by both customers and staff
- 8. No super-strength beer, lagers or ciders of 5.5% ABV (alcohol by volume) or above shall be sold at the premises
- 9. No more than 15% of the sales area to be used at any one time for the sale, exposure for sale, or display of alcohol
- 10. Prominent signage indicating the permitted hours for the sale of alcohol shall be displayed so as to be visible before entering the premises, where alcohol is on public display, and at the point of sale
- 11. A proof of age scheme, such as Challenge 21, shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport and PASS accredited Proof of Age cards
- 12. A log shall be kept detailing all refused sales of alcohol. The log should include the date and time of the refused sale and the name of the member of staff who refused the sale. The log shall be available for inspection at the premises by the police or an authorised officer of the City Council at all times whilst the premises are open
- 13. Staff training will be given to ensure that in the case of any doubt whether a purchaser is over the age of 18 to refuse the sale of alcohol unless valid ID is produced /
- 14. All sales of alcohol for consumption off the premises shall be in sealed containers only, and shall not be consumed on the premises.
- 15. There shall be no self service of spirits on the premises except for spirit mixers below 5.5% Alcohol by Volume.
- 16. A notice shall be prominently displayed at the exit requesting patrons to respect the needs of local residents and leave the area quietly.



WITNESS STATEMENT OF NICHOLAS PARKER

Visit to Norris Newsagent, 115 Lupus Street, 13th November 2014.

- I, Nicholas Parker, Officer of Her Majesty's Revenue & Customs, (HMRC) based at Custom House, 20 Lower Thames Street, London EC3R 6EE WILL SAY as follows:
- Cn 13th November 2014, accompanied by Officer Stapleton of HMRC, I attended Norris Newsagent at 115 Lupus Street, London SW1V 3EN under the authority of section 112 of the Customs & Excise Management Act. I entered the premises at 16:10 hours.
- 2. The owner of a shop, Mr Shusilkumar Bhavsar, who was present throughout the visit was asked to provide purchase records in respect of the canned beers and wine in the shop to demonstrate that the UK duty had been paid. Mr Bhavsar admitted that some of the wine and most of the canned beers on the premises had been purchased without an invoice. This admission led me to believe, on the balance of probabilities that UK duty had not been paid on the alcohol in question.
- As a result of this admission I made the decision to seize the alcohol detailed below, pursuant to section 139 of the Customs & Excise Management Act 1979 as it was liable to forfeiture on the basis that, on the balance of probabilities, the UK excise duty had not been paid.
- 4 In total the following quantilies were seized:

888.56 litres of beer 36 litres of wine

5. The duty figures of the seized stock amounted to £1224.55, including VAT.

6. Mr Bhavsar was issued with a seizure information notice, a warning letter and a booklet explaining his right to appeal the seizure at 16:55 hours. To date, I am not aware of any appeal against the seizure.

At 11:00 hrs we were briefed by PS Chamberlain also present two Female volunteer police cadets who were both under age of 18 years known as Cadets 4 and 5 respectively regarding their deployment and the method to be adopted. They were in casual plain clothes. Following this briefing digital photographs of each of the cadets and a photocopy of their birth certificates were taken. These are produced as exhibits in a separate statement. At about 14:30 hrs we drove to LUPUS STREET SW1 in a marked police vehicle. We parked at the next junction intending to conduct a test purchase at NORRIS convenience store LUPUS STREET SW1. Cadet 4 and 5 were verbally briefed and handed a £10 note each. I then walked a short distance and entered NORRIS convenience store at LUPUS STREET SW1. I went to the front of the shop. Approximately 1 minute later I saw Cadet 4 & 5 enter store. I was looking at Birthday cards on display. I had cadet 4 & 5 in full view at all times. I saw them select two bottles of WKD VODKA alcohol drinks in purple bottle 275ml from a chiller cabinet. After a short time they then went to the counter to pay. I stood to the side of birthday card display watching cadets. There were few other customers in the store at that time. At no time did I speak with the Cadets or give the impression I was with them. The Cadets placed the two bottles of WKD VODKA drink on the counter. They were then served by an Asian male aged about 20 years wearing a grey hooded top and blue denim trousers, who I now know to be Mr Ankit PATEL. Mr PATEL looked at the Cadets and had not said anything. He rang the item into the cash till and placed the bottles of WKD drinks into a black carrier bag and handed it to Cadet 5 "How much is that?" Cadet 5 said "£2.58 Two pounds Fifty Eight pence". Cadet 5 handed over the £10 note. PATEL gave her change. At no point whilst the Cadets were in the shop or during the transaction did PATEL ask them their age or ask for ID.

Cadet 5 took the bottle and left the shop with Cadet 4. I did not purchase anything from the shop after them. I followed both back to the Van with Special PC Kokonis and informed Sergeant Chamberlain and we discussed

what had taken place. Cadet 5 handed me two bottle of WKD - I then placed this into Evidence bag and sealed it reference D43474115 as Exhibit CU/1. Myself PS Chamberlain and Pc Baldock then returned to the shop. On entering I saw PATEL stood behind the counter with a lady shop owner who I now know to be Mrs Kalpna PATEL. I identified myself by showing my warrant card and introduced myself. I then said "A few minutes ago a young girls came in and bought two bottles of WKD alcohol. These girls are police cadets and work for me their photographs shown by PS Chamberlain, You served them and I was stood behind witnessing whilst you did this. They are both under age of eighteen. At no point did you ask them their age or ask for ID. It is an offence to sell alcohol to anyone under the age of 18". PATEL appeared very nervous and said "I thought they were older". I reiterated what I had witnessed. We then made enquiries as to his position in the store. He had stated that he was family member helping out Mrs KALPNA PATEL the owner. Sergeant Chamberlain verified KALPNA Patel's details who took full responsibility of the transaction and had apologised for this matter explaining it would not happen again and issued her with a PND fixed penalty notice for the offence of supplying alcohol to persons under 18. The PND was fully explained. I informed PATEL that the Licensing Officer and Trading Standards would be informed of the incident.

Myself PC Baldock and PS Chamberlain left the store.




