## POLICY CONSIDERATIONS

The City of Westminster statement of licensing policy applies to all applications where relevant representations have been made. The Licensing Sub-Committee is required to have regard to the City of Westminster statement of Licensing Policy and the guidance issued by the Secretary of state under Section 182 of the Licensing Act 2003.

## **GUIDANCE CONSIDERATIONS**

The Licensing Authority is required to have regard to any guidance issued by the Secretary of State under the Licensing Act 2003.

## LIVE MUSIC ACT 2012

The Live Music Act amends the Licensing Act 2003 by:

- removing the licensing requirement for amplified live music taking place between 8am and 11pm before audiences of no more than 200 persons on premises authorised by a premises licence or club premises certificate to supply alcohol for consumption on the premises (at a time when those premises are open for the purposes of being used for the supply of alcohol for consumption on the premises), subject to the right of a licensing authority to impose conditions about live music following a review of a premises licence or club premises certificate
- removing the licensing requirement for amplified live music taking place between 8am and 11pm before audiences of no more than 200 persons in workplaces not otherwise licensed under the 2003 Act (or licensed only for the provision of late night refreshment)
- removing the licensing requirement for unamplified live music taking place between 8am and 11pm in any place, subject to the right of a licensing authority to impose conditions about live music following a review of a premises licence or club premises certificate relating to premises authorised to supply alcohol for consumption on the premises
- removing the licensing requirement for the provision of entertainment facilities
- widens the licensing exemption for live music that is integral to a performance of Morris dancing or dancing of a similar type, so that the exemption applies to both live or recorded music instead of just unamplified live music in that instance.

The Condition was added to the premises licence pursuant to a minor variation application by the premises licence holder on 17 September 2015 following a discussion with the Westminster Licensing Inspectorate Francis Keegan. However, at the time of the application the premises licence holder had not fully appreciated the true effect of the Condition. Further, at the time of the application the licence holder had been pressured into agreeing the Condition and being threatened with a formal review and revocation of the premises licence. She had not been advised properly that there is no genuine requirement for the imposition of the Condition which, it is submitted, is a disproportionate suggestion by the Westminster Licensing Inspectorate in response to his site inspection.

It is now apparent to the premises licence holder that the Condition is very draconian and restrictive indeed as it prohibits Mr Tang from being in the premises at all, or even to make any decisions concerning his restaurant business. The effect of the Condition is that Mr Tang could not even have a meal in his own restaurant, or from making trivial decisions concerning the business, for example to change the menu, or to order stocks for his restaurants etc.

It is submitted that the removal of Condition 32 will not have any adverse impact on the four licensing objectives. There is no evidence that restricting Mr Tang from accessing the premises or be involved in the running of the business will promote the licensing objectives. Mr Tang has acknowledged the previous oversight in the management of the premises and is committed to ensuring his premises operates in accordance with the licensing conditions in future. This can be seen by him agreeing to remove himself as the DPS of the premises. The premises licence holder have also agreed for additional Conditions 33-37 to be added unto the premises licence in the minor variation application of 17 September 2015, including agreeing for a duty manager (who will be a personal licence holder) to be at the premises at all times. Mr Tang is an experienced restaurateur with many years of experience in the business. By removing Condition 32 this will enable Mr Tang to devote his time, effort and energy into ensuring the premises is run in accordance with the relevant legislations and regulations.

I refer to the application for variation of the Premises Licence.

The premises are located within the West End Cumulative Impact Area as stated in the City of Westminster's Statement of Licensing Policy.

This representation is based on the plan reference 003249 dated 20/01/2016 and the operating schedule submitted.

The applicant is seeking the following

- 1. To remove condition 32 that states Mr Desmond Sai Loi Tang shall not be permitted to be upon the licensed premises at any time, and he shall not be involved in the management of the venue or the staff working there.
- 2. Vary the licence plan with the plan attached to this application.

I wish to make the following representation

- 1. The removal of condition 32 will impact on Crime and Disorder and have the likely effect of causing an increase in Public Nuisance within the West End CI Area.
- The applicant has not stated the alterations that have or are likely to be made to the premises which may impact on Public Safety or have the likely effect of an increase in public nuisance within the West End CI Area.

The applicant has provided information in support of the application but this does not fully address the concerns of Environmental Health.

Should you wish to discuss the matter further please do not hesitate to contact me.

I will be representing Environmental Health at the forthcoming licensing sub-committee hearing on the 24<sup>th</sup> March. In support of my representation I will be calling Francis Keegan and Siv Kumar to give evidence. A Witness Statement and emails from Mr Francis Keegan can be found in **Appendix 4** of the report.

The Environmental Health Service has withdrawn their representation to the change of layout at the premises but will be maintaining their representation against the removal of Condition 32 on the licence.



Summary of incident and investigation.

On Thursday 2nd July 2015 Francis KEEGAN and Siva KUMAR were in plain clothes and on duty as Licensing inspectors from Westminster Council. At approximately 0220 hours they attempted to enter 17 Lisle street as they believed licensed activity was taking place after hours. They both showed their council ID to a male at the entrance who claimed that he did not work there. They waited for a short while before proceeding up the stairs unaccompanied. They walked into a room of about 30 people. Francis was suddenly approached by Mr TANG and before he had chance to formally introduce himself and his colleague Mr TANG started shouting at him in Chinese and poked him in the ribs and pushed him. Francis KEEGAN protested and asked him to not touch him, saying clearly that he was on 'official business' and that he should not touch him. MR TANG did not understand and grabbed his right arm and pulled him towards the door in order to eject him. At this point MR TANGS wife pushed in between them both and released MR KEEGANS arm from MR TANGS GRIP. Mr KEEGANS bag fell on the floor and as KUMAR tried to pick it up MR TANG grabbed his shirt. MR TANG eventually let go and was dragged away by his wife who then dealt with the inspectors. Francis did not sustain any visible injury.

The venue was visited by myself two days after the incident and CCTV footage was requested as they had cameras fitted in the venue. At the time the staff member was unable to operate the CCTV so was unable to show me any footage ( this was not a condition on the licence at the time). I returned the following day and met with Mr TANG who was able to operate the CCTV but informed me it had not been recording as he was unable to find any footage. I looked at the system and observed that no data was being stored on the Hard drive. I was unable to tell if data on the hard drive had been recently deleted.

Mr Tang was interviewed under caution and during interview MR TANG denied assault and poking Francis in the ribs stating that he was at a staff party which was not open to the public and no licensable activity was taking place. He had been drinking and when he saw the two males enter he did not know who they were as they were not in uniform and were not displaying any ID. As he was in charge of the party he did not want anyone he did not know entering and so attempted to stop them using his arms to block them. He stated he then tried to lead them to the door so they could leave. He states that as soon as they identified themselves properly he stopped and walked away and let his wife deal with the situation. He states he put out his arm to block Francis and Siva to stop them coming further into the room, but made no attempt to assault them.

CCTV was checked however the footage had been not recorded. There are no known independent witnesses No visible injuries.

The evidence was passed to the Evidence review officer who reviewed the case and made the decision of no further action due to insufficient evidence.

I am the above named person and am employed by the City of Westminster as a City Inspector. Part of my role is to monitor licensed venues, and I am authorised to enter and inspect such venues.
On Thursday 2nd July 2015 I was on duty in the West End with my colleague, Mr S Kumai
At approximately 0220 hours we were in Lisle Street when we were passing the venue known as Super Star Restaurant at 17 Lisle Street, London WC2.
noticed the entrance door of the venue was open, and a number of Chinese looking ladie eft the venue. I noticed that the door to the venue was being held open for the ladies in question by a young Chinese man dressed in black. Suddenly the door closed and I vitnessed the man lock the door shut.
Ar Kumar and I approached the venue, the ground floor of which was in darkness. I saw th irst page of the Part B/Summary of a premises licence displayed in the window, which suggested that the venue should have ceased trading at 1am.
knocked firmly on the venue's glass door and held my Council issued dentification/photocard to the glass. The young man approached and I called out Westminster Council, Licensing visit, open up please". There was some delay but the oung man eventually opened the door using a key and I explained who I was and that I vanted to see the manager. I could hear very loud music coming from upstairs. The man sked me to wait at the entrance, but we said we preferred to come in (which we did).
saw an elderly man at the rear of the venue's ground floor, sitting at a table and using a ptop, and he announced that there was a staff party taking place upstairs. I thanked him f olunteering this information.
asked the younger man where the manager was, but no useful answer was given. I then oticed that (what I believed to be ) a fire door between the room I was in and the stairwell as wedged fully open by a chair. Both men claimed that they did not work at the venue even the younger man, who had the key to the entrance door) I announced that I had waite ng enough, and was going upstairs. This seemed to upset the young man and he stepped

Continuation of Statement of: FRANCIS KEEGANI forward. I told him that I was an authorised Council Officer, and I asked him to step back as he was invading my space.

In the stairwell I saw, and pointed out to my colleague, that not only was a fire door (?) wedged open, but that numerous items (mainly cardboard boxes) were being stored in the emergency escape route.

We ascended the stairs and I entered a large room. I saw many Chinese people (30 or more) sitting and standing. There were many plates and platters with food on them, and many opened bottles of "Tiger" beer. I asked a few people who looked like they worked there (as they were dressed as waiting staff), but they all claimed that they did not. I walked slowly around the room to ascertain exactly what was going on, when suddenly a man who I recognized approached me. Before I had a chance to formally introduce my colleague and I, the man started shouting at me in Chinese, and poking me in the ribs and pushing me. I protested, asking him not to touch me, saying clearly that I was on official business, and that he should not touch me. He did not seem to listen, and then suddenly he grabbed my right arm firmly and started to pull me towards the door leading to the stairs.

I heard a scream from behind me, and looked to see an older Chinese lady (who I also recognized) who was clearly in distress. She rushed forward, as did a younger man, and they (and others) got between me and the man who had grabbed my arm, and they struggled with him.

I was concerned that I may fall over because of his actions and /or that he would get me to the stairs and throw me down them. I resisted his efforts to pull me forward, and used my free arm to push against the door frame

I could see my colleague to my right, who was obviously concerned but who (quite rightly, I feel) stood back from the "action"

Suddenly the group before me seemed to stumble, and the man released my arm, and I suddenly lost by back-pack, which had been slung over my right shoulder. I did not worry about this, being merely happy that I was now in less danger. However, Mr Kumar stepped forward to get my bag, and before I could tell him not to bother the assailant grabbed his shirt collar. There was a great deal of shouting by now from the attacker, the older lady, and others, but after a few moments I could see that my colleague was free and I indicated that he should join me at a vacant table some distance from the continuing violent scene, which involved a great deal of shouting and struggling

Suddenly the man who had grabbed me was nowhere to be seen, and the older lady mentioned above (who was clearly distraught) gave some instructions to a number of people, one of whom came forward eventually and spoke to us, confirming that he was a member of staff. He was unable to produce the full licence (Part A) when requested to do so. Whilst waiting for him to find the document, my colleague and I checked the upper floors which were by then empty but were laid out as private / karaoke rooms. During this time my colleague mentioned that he had seen people playing cards when he first entered the first floor, and that he saw money on the table, but I did not see this myself.

However, I felt that what the staff member (and others) said to us was unhelpful and (I am sure) untruthful. However, he confirmed that the venue had a good CCTV system and I said that he should ensure that all CCTV images relating to our visit should be retained as potential evidence.

By now the music had died down considerably, and I pointed out a few matters of concern to the members of staff already mentioned, and soon after this my colleague and I left the venue having issued some strong words of advice to those who would listen

I was quite shaken by the incident and on reflection I had cause to think that my personal safety had been put at risk. What concerned me most was the totally unreasonable behaviour of the man who attacked me. He simply refused to listen to anything I said, and he grabbed hold of my arm very firmly and would not let go until he was forced to do so. I believe he would have thrown me down the stairs if he had been able/allowed to do so

Upon my return to the office I submitted a brief report by email about what had happened to my line manager (Andrew Ralph) which I now see contains a number of typing error On 6 July I returned to the venue with another colleague (Tony Miah) and we also visited another venue (at 15 Lisle Street). Eventually, Mr Desmond Sai Loi Tang (the licensee for both venues) came forward. I recognised him as the man who had attacked me, and he agreed that he was the person in question, and that the lady who had screamed (and come to my aid) was the other licensee (and his wife), Mrs Tang

On 6 and 7 July 2015 I told the Westminster Police Licensing team that I wanted to bring a formal complaint against Mr Desmond Sai Loi Tang , and asked them to secure the CCTV images form the venue's system which I feel will fully confirm my version of events

I asked them to also deliver to the venue a copy of a letter I had already sent to Mrs Tang, and which has now been acknowledged by Mr P H Yeung (of 3 Rupert Court, London. W1) who says he has been instructed by her in relation to the "unfortunate incident".

I would describe Mr TANG as a Chinese looking male, Late 50's, overweight and approximately 5'6" tall. He has dark straight short hair and was wearing a dark jacket.

The assault on me lasted about 2 minutes, at all times I had a clear and unobstructed view of Mr TANG and the visibility was good due to the room being well lit. I do recognise Mr TANG as I have met him on a previous occasion at his other restaurant.

At no time did I give anyone permission to assault me in this way. I am happy to attend court if needed.

If the premises licence holder is not present, there shall be a duty manager upon and in charge of the venue whenever it is open and trading, and whenever any person (other than staff members) are still present \*. The licensee or duty manager shall make themselves known promptly to any authorised persons who visit or inspect the venue and s/he shall assist them in their duties.

In the absence of the premises licence holder, a letter of delegations specifically naming the duty manager(s) shall be prominently displayed near the entrance of the venue.

The licensee or duty manager shall ensure that the venue is operated safely and that no unlawful activities are permitted to take place within the venue, and shall also ensure that all licensable activities are strictly limited to those areas covered by the licence and to the permitted hours.

The entrance to the venue shall not be locked whenever any persons (other than staff members) are still present, and authorised officers shall be given prompt access to all parts of the premises at any reasonable time.

## CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE AND CONDITIONS PROPOSED BY A PARTY TO THE HEARING

When determining an application for a variation premises licence under the provisions of the Licensing Act 2003, the licensing authority must, unless it decides to reject the application, grant the licence subject to the conditions which are indicated as mandatory in this schedule.

At a hearing the licensing authority may, in addition, and having regard to any representations received, grant the licence subject to such conditions which are consistent with the operating schedule submitted by the applicant as part of their application, or alter or omit these conditions, or add any new condition to such extent as the licensing authority considers appropriate for the promotion of the licensing objectives.

This schedule lists those conditions which are consistent with the operating schedule, or proposed as appropriate for the promotion of the licensing objectives by a responsible authority or an interested party as indicated. These conditions have not been submitted by the licensing service but reflect the positions of the applicant, responsible authority or interested party and have not necessarily been agreed

#### Conditions: On Current Licence -

#### Mandatory:

- 1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
- 2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
- 3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
- 4. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
  - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
    - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the

period in which the responsible person is authorised to sell or supply alcohol), or

- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
    - (a) a holographic mark, or
    - (b) an ultraviolet feature.
- 7. The responsible person must ensure that—
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

- (i) beer or cider:  $\frac{1}{2}$  pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

- 8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 8(ii) For the purposes of the condition set out in paragraph 8(i) above -
  - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - (b) "permitted price" is the price found by applying the formula -

P = D+(DxV)

Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
  - (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club

present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 8(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 8(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

## Annex 2 – Conditions consistent with the operating Schedule

- 9. The premises shall only operate as a restaurant:
  - a. in which customers are shown to their table;
  - b. where the supply of alcohol is by waiter or waitress service only;
  - which provide food in the form of substantial table meals that are prepared on the premises and are served and consumed at the table using non disposable crockery;
  - d. which do not provide any take away service of food or drink for immediate consumption;
  - e. which do not provide any take away service of food or drink after 23.00, and
  - f. where alcohol shall not be sold or supplied, otherwise than for consumption by persons who are seated in the premises and bona fide taking substantial table meals there, and provided always that the consumption of alcohol by such persons is ancillary to taking such meals.
- 10. Notwithstanding this condition customers are permitted to take from the premises part consumed and resealed bottles of wine supplied ancillary to their meal.
- 11. Substantial food and non-intoxicating beverages, including drinking water, shall be available in all parts of the premises where alcohol is sold or supplied for consumption on the premises.
- 12. No noise shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
- 13. All windows and external doors shall be kept closed after 21:00 hours, or at any time when regulated entertainment takes place, except for the immediate access and egress of persons.

- 14. All sales of alcohol for consumption off the premises shall be in sealed containers only, and shall not be consumed on the premises.
- 15. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and businesses and leave the area quietly.
- 16. Notices shall be prominently displayed at any area used for smoking requesting patrons to respect the needs of local residents and use the area quietly.
- 17. All waste shall be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times.
- 18. The number of persons permitted in the premises at any one time (excluding staff) shall not exceed:

Ground Floor	90 persons
First Floor	20 persons

- 19. During the hours of operation of the premises, the licence holder shall ensure sufficient measures are in place to remove and prevent litter or waste arising or accumulating from customers in the area immediately outside the premises, and that this area shall be swept and or washed, and litter and sweepings collected and stored in accordance with the approved refuse storage arrangements by close of business.
- 20. A Challenge 21 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 21. The licence holder shall ensure that all relevant staff are trained to ask any customer attempting to purchase alcohol, who appears to be under the age of 21 years (or older if the licence holder so elects) for evidence of age. This evidence shall be photographic, such as passport or photographic driving licence until other effective identification technology (for example, thumb print or pupil recognition) is introduced. All cashiers will be instructed, through training, that a sale shall not be made unless this evidence is produced.
- 22. All relevant staff will receive refresher training on relevant alcohol laws and the licence holder's policy on challenging for ID. Such training to take place at least twice a year. Records will be maintained at the premises containing information about the training of any person who may make a sale of alcohol including the date of their training and the nature of the training undertaken. The relevant documentation shall be produced on request to a police officer or a relevant officer of a responsible authority.
- 23. There shall be no striptease or nudity, and all persons shall be decently attired at all times, except when the premises are operating under the authority of a Sexual Entertainment Venue licence.
- 24. There shall be no sales of hot food or hot drink for consumption off the premises after 23.00.

- 25. No more than (15)% of the sales area shall be used at any one time for the sale, exposure for sale, or display of alcohol.
- 26. There shall be no self service of alcohol on the premises.
- 27. The premises licence holder shall ensure that any patrons drinking and/or smoking outside the premises do so in an orderly manner and are supervised by staff so as to ensure that there is no public nuisance or obstruction of the public highway.
- 28. Patrons permitted to temporarily leave and then re-enter the premises, eg to smoke, shall not be permitted to take drinks or glass containers with them.
- 29. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the preceding 31 day period.
- 30. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
- 31. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police, which will record the following:
  - (a) all crimes reported to the venue;
  - (b) all ejections of patrons;
  - (c) any complaints received concerning crime and disorder;
  - (d) any incidents of disorder;
  - (e) all seizures of drugs or offensive weapons;

(f) any faults in the CCTV system or searching equipment or scanning equipment;

(g) any refusal of the sale of alcohol;


- (h) any visit by a relevant authority or emergency service.
- 32. Mr Desmond Sai Loi Tang shall not be permitted to be upon the licensed premises at any time, and he shall not be involved in the management of the venue or the staff working there.
- 33. If the premises licence holder is not present, there shall be a duty manager upon and in charge of the venue whenever it is open and trading, and whenever any person (other than staff members) are still present. The effect of this condition is that a duty manager cannot leave the venue at relevant times (even temporarily)

unless there is another properly nominated manager also upon the venue to take his/her place.

- 34. This duty manager shall be the holder of a personal licence, evidence of which shall be produced to authorised persons upon request. The licensee or duty manager shall make themselves known promptly to any authorised persons who visit or inspect the venue and s/he shall assist them in their duties.
- 35. In the absence of the premises licence holder, a letter of delegations specifically naming the duty manager(s) shall be prominently displayed near the entrance of the venue.
- 36. The licensee or duty manager shall ensure that the venue is operated safely and that no unlawful activities are permitted to take place within the venue, and shall also ensure that all licensable activities are strictly limited to those areas covered by the licence and to the permitted hours.
- 37. The entrance to the venue shall not be locked whenever any persons (other than staff members) are still present, and authorised officers shall be given prompt access to all parts of the premises at any reasonable time.



Applicant submissions:	The restaurant business is run by Mr Tang and his wife Mrs Lai Mei Tang (the premises licence holder and applicant) through their company. As the de-facto owner of the business, it is natural for Mr Tang to be at the premises and be involved in the management of the venue or the staff working there and as such Condition 11 is unreasonably restricting him from running his business and in breach his human rights to earn his living.
	The Condition was added to the premises licence pursuant to a minor variation application by the premises licence holder on 17 September 2015 following a discussion with the Westminster Licensing Inspectorate Francis Keegan.
	However, at the time of the application the premises licence holder had not fully appreciated the true effect of the Condition. Further, at the time of the application the licence holder had been pressured into agreeing the Condition and being threatened with a formal review and revocation of the premises licence. She had not been

advised properly that there is no genuine requirement for the imposition of the Condition which, it is submitted, is a disproportionate suggestion by the Westminster Licensing Inspectorate in response to his site inspection. It is now apparent to the premises licence holder that the Condition is very draconian and restrictive indeed as it prohibits Mr Tang from being in the premises at all, or even to make any decisions concerning his restaurant business. The effect of the Condition is that Mr Tang could not even have a meal in his own restaurant, or from making trivial decisions concerning the business, for example to change the menu, or to order stocks for his restaurants etc.
It is submitted that the removal of Condition 11 will not have any adverse impact on the four licensing objectives. There is no evidence that restricting Mr Tang from accessing the premises or be involved in the running of the business will promote the licensing objectives.
Mr Tang has acknowledged the previous oversight in the management of the premises and is committed to ensuring his premises operate in accordance with the licensing conditions in future. This can be seen by him agreeing to remove himself as the DPS of the premises. The premises licence holder have also agreed for additional Conditions 12-18 to be added unto the premises licence in the minor variation application of 17 September 2015, including agreeing for a duty manager (who will be a personal licence holder) to be at the premises at all times and also agreeing for CCTV to be installed at the premises.
Mr Tang is an experienced restaurateur with many years of experience in the business. By removing Condition 11 this will enable Mr Tang to devote his time, effort and energy into ensuring the premises is run in accordance with the relevant legislations and regulations.



#### Summary of incident and investigation.

On Thursday 2nd July 2015 Francis KEEGAN and Siva KUMAR were in plain clothes and on duty as Licensing inspectors from Westminster Council. At approximately 0220 hours they attempted to enter 17 Lisle street as they believed licensed activity was taking place after hours. They both showed their council ID to a male at the entrance who claimed that he did not work there. They waited for a short while before proceeding up the stairs unaccompanied. They walked into a room of about 30 people. Francis was suddenly approached by Mr TANG and before he had chance to formally introduce himself and his colleague Mr TANG started shouting at him in Chinese and poked him in the ribs and pushed him. Francis KEEGAN protested and asked him to not touch him, saying clearly that he was on 'official business' and that he should not touch him. MR TANG did not understand and grabbed his right arm and pulled him towards the door in order to eject him. At this point MR TANGS wife pushed in between them both and released MR KEEGANS arm from MR TANGS GRIP. Mr KEEGANS bag fell on the floor and as KUMAR tried to pick it up MR TANG grabbed his shirt . MR TANG eventually let go and was dragged away by his wife who then dealt with the inspectors. Francis did not sustain any visible injury.

The venue was visited by myself two days after the incident and CCTV footage was requested as they had cameras fitted in the venue. At the time the staff member was unable to operate the CCTV so was unable to show me any footage (this was not a condition on the licence at the time). I returned the following day and met with Mr TANG who was able to operate the CCTV but informed me it had not been recording as he was unable to find any footage. I looked at the system and observed that no data was being stored on the Hard drive. I was unable to tell if data on the hard drive had been recently deleted.

Mr Tang was interviewed under caution and during interview MR TANG denied assault and poking Francis in the ribs stating that he was at a staff party which was not open to the public and no licensable activity was taking place. He had been drinking and when he saw the two males enter he did not know who they were as they were not in uniform and were not displaying any ID. As he was in charge of the party he did not want anyone he did not know entering and so attempted to stop them using his arms to block them. He stated he then tried to lead them to the door so they could leave. He states that as soon as they identified themselves properly he stopped and walked away and let his wife deal with the situation. He states he put out his arm to block Francis and Siva to stop them coming further into the room, but made no attempt to assault them.

CCTV was checked however the footage had been not recorded. There are no known independent witnesses No visible injuries.

The evidence was passed to the Evidence review officer who reviewed the case and made the decision of no further action due to insufficient evidence.

Continuation of Statement of: FRANCIS KEEGANI forward. I told him that I was an authorised Council Officer, and I asked him to step back as he was invading my space.

In the stairwell I saw, and pointed out to my colleague, that not only was a fire door (?) wedged open, but that numerous items (mainly cardboard boxes) were being stored in the emergency escape route.

We ascended the stairs and I entered a large room. I saw many Chinese people (30 or more) sitting and standing. There were many plates and platters with food on them, and many opened bottles of "Tiger" beer. I asked a few people who looked like they worked there (as they were dressed as waiting staff), but they all claimed that they did not. I walked slowly around the room to ascertain exactly what was going on, when suddenly a man who I recognized approached me. Before I had a chance to formally introduce my colleague and I, the man started shouting at me in Chinese, and poking me in the ribs and pushing me. I protested, asking him not to touch me, saying clearly that I was on official business, and that he should not touch me. He did not seem to listen, and then suddenly he grabbed my right arm firmly and started to pull me towards the door leading to the stairs.

I heard a scream from behind me, and looked to see an older Chinese lady (who I also recognized) who was clearly in distress. She rushed forward, as did a younger man, and they (and others) got between me and the man who had grabbed my arm, and they struggled with him.

I was concerned that I may fall over because of his actions and /or that he would get me to the stairs and throw me down them. I resisted his efforts to pull me forward, and used my free arm to push against the door frame

I could see my colleague to my right, who was obviously concerned but who (quite rightly, I feel) stood back from the "action"

Suddenly the group before me seemed to stumble, and the man released my arm, and I suddenly lost by back-pack, which had been slung over my right shoulder. I did not worry about this, being merely happy that I was now in less danger. However, Mr Kumar stepped forward to get my bag, and before I could tell him not to bother the assailant grabbed his shirt collar. There was a great deal of shouting by now from the attacker, the older lady, and others, but after a few moments I could see that my colleague was free and I indicated that he should join me at a vacant table some distance from the continuing violent scene, which involved a great deal of shouting and struggling

Suddenly the man who had grabbed me was nowhere to be seen, and the older lady mentioned above (who was clearly distraught) gave some instructions to a number of people, one of whom came forward eventually and spoke to us, confirming that he was a member of staff. He was unable to produce the full licence (Part A) when requested to do so. Whilst waiting for him to find the document, my colleague and I checked the upper floors which were by then empty but were laid out as private / karaoke rooms. During this time my colleague mentioned that he had seen people playing cards when he first entered the first floor, and that he saw money on the table, but I did not see this myself.

However, I felt that what the staff member (and others) said to us was unhelpful and (I am sure) untruthful. However, he confirmed that the venue had a good CCTV system and I said that he should ensure that all CCTV images relating to our visit should be retained as potential evidence.

By now the music had died down considerably, and I pointed out a few matters of concern to the members of staff already mentioned, and soon after this my colleague and I left the venue having issued some strong words of advice to those who would listen

I was quite shaken by the incident and on reflection I had cause to think that my personal safety had been put at risk. What concerned me most was the totally unreasonable behaviour of the man who attacked me. He simply refused to listen to anything I said, and he grabbed hold of my arm very firmly and would not let go until he was forced to do so. I believe he would have thrown me down the stairs if he had been able/allowed to do so

Upon my return to the office I submitted a brief report by email about what had happened to my line manager (Andrew Ralph) which I now see contains a number of typing error On 6 July I returned to the venue with another colleague (Tony Miah) and we also visited another venue (at 15 Lisle Street). Eventually, Mr Desmond Sai Loi Tang (the licensee for both venues) came forward. I recognised him as the man who had attacked me, and he agreed that he was the person in question, and that the lady who had screamed (and come to my aid) was the other licensee (and his wife), Mrs Tang

On 6 and 7 July 2015 I told the Westminster Police Licensing team that I wanted to bring a formal complaint against Mr Desmond Sai Loi Tang , and asked them to secure the CCTV images form the venue's system which I feel will fully confirm my version of events

I asked them to also deliver to the venue a copy of a letter I had already sent to Mrs Tang, and which has now been acknowledged by Mr P H Yeung (of 3 Rupert Court, London. W1) who says he has been instructed by her in relation to the "unfortunate incident".

I would describe Mr TANG as a Chinese looking male, Late 50's, overweight and approximately 5'6" tall. He has dark straight short hair and was wearing a dark jacket.

The assault on me lasted about 2 minutes, at all times I had a clear and unobstructed view of Mr TANG and the visibility was good due to the room being well lit. I do recognise Mr TANG as I have met him on a previous occasion at his other restaurant.

At no time did I give anyone permission to assault me in this way. I am happy to attend court if needed.

The licensee or duty manager shall ensure that the venue is operated safely and that no unlawful activities are permitted to take place within the venue, and shall also ensure that all licensable activities are strictly limited to those areas covered by the licence and to the permitted hours.

The entrance to the venue shall not be locked whenever any persons (other than staff members) are still present, and authorised officers shall be given prompt access to all parts of the premises at any reasonable time.

CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE AND CONDITIONS PROPOSED BY A PARTY TO THE HEARING

When determining an application for a variation premises licence under the provisions of the Licensing Act 2003, the licensing authority must, unless it decides to reject the application, grant the licence subject to the conditions which are indicated as mandatory in this schedule.

At a hearing the licensing authority may, in addition, and having regard to any representations received, grant the licence subject to such conditions which are consistent with the operating schedule submitted by the applicant as part of their application, or alter or omit these conditions, or add any new condition to such extent as the licensing authority considers appropriate for the promotion of the licensing objectives.

This schedule lists those conditions which are consistent with the operating schedule, or proposed as appropriate for the promotion of the licensing objectives by a responsible authority or an interested party as indicated. These conditions have not been submitted by the licensing service but reflect the positions of the applicant, responsible authority or interested party and have not necessarily been agreed

#### Conditions: On Current Licence -

#### Mandatory:

- 1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
- 2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
- 3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
- 4. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
  - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
    - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the

period in which the responsible person is authorised to sell or supply alcohol), or

- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
    - (a) a holographic mark, or
    - (b) an ultraviolet feature.
- 7. The responsible person must ensure that—
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

- (i) beer or cider:  $\frac{1}{2}$  pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

- 8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 8(ii) For the purposes of the condition set out in paragraph 8(i) above -
  - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - (b) "permitted price" is the price found by applying the formula -

P = D+(DxV)

Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
  - (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club

present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 8(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 8(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Conditions reproducing the effect of conditions subject to which the relevant existing licences have effect

- 9. Alcohol may be sold or supplied:
  - (a) On weekdays, other than Christmas Day, Good Friday or New Year's Eve from 10.00 to 00.00;
  - (b) On Sundays, other than Christmas Day or New Year's Eve, and on Good Friday: 12.00 to 23:30;
  - (c) On Christmas Day: 12.00 to 22.30;
  - (d) On New Year's Eve, except on a Sunday, 11.00 to 23.00;
  - (e) On New Year's Eve on a Sunday, 12.00 to 22.30;
  - (f) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).

The above restrictions do not prohibit:

(a) during the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;

(b) during the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking table meals there if the alcohol was supplied for consumption as ancillary to the meals;

(c) the sale or supply of alcohol to or the consumption of alcohol by any person residing in the licensed premises;

(d) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;

(e) the sale of alcohol to a trader or registered club for the purposes of the trade or club;

(f) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;

(g) the taking of alcohol from the premises by a person residing there;

(h) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied;

(i) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

In this condition, any reference to a person residing in the premises shall be construed as including a person not residing there but carrying on or in charge of the business on the premises.

10. Alcohol shall not be sold or supplied unless the premises have been structurally and bona fide used, or intended to be used, for the purposes of habitually providing the customary main meal at midday or in the evening, or both, for the accommodation of persons frequenting the premises.

#### Annex 2 – Conditions consistent with the operating Schedule

- 11. Mr Desmond Sai Loi Tang shall not be permitted to be upon the licensed premises at any time, and he shall not be involved in the management of the venue or the staff working there.
- 12. If the premises licence holder is not present, there shall be a duty manager upon and in charge of the venue whenever it is open and trading, and whenever any person (other than staff members) are still present. The effect of this condition is that a duty manager cannot leave the venue at relevant times (even temporarily) unless there is another properly nominated manager also upon the venue to take his/her place.
- 13. This duty manager shall be the holder of a personal licence, evidence of which shall be produced to authorised persons upon request. The licensee or duty manager shall make themselves known promptly to any authorised persons who visit or inspect the venue and s/he shall assist them in their duties.
- 14. In the absence of the premises licence holder, a letter of delegations specifically naming the duty manager(s) shall be prominently displayed near the entrance of the venue.
- 15. The licensee or duty manager shall ensure that the venue is operated safely and that no unlawful activities are permitted to take place within the venue, and shall also ensure that all licensable activities are strictly limited to those areas covered by the licence and to the permitted hours.
- 16. The entrance to the venue shall not be locked whenever any persons (other than staff members) are still present, and authorised officers shall be given prompt access to all parts of the premises at any reasonable time.
- 17. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the preceding 31 day period.
- 18. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.

- 20. The premises maybe kept open for the purposes of this licence from midnight on each of the days Sunday to Thursday to 1:00 am on the day following and from midnight on the days Friday and Saturday to 2:00am on the day following:
- 21. The number of persons that can be accommodated shall not exceed: Ground floor 60, First floor 60 (excluding staff)


