I write in relation to the application submitted for a New Premises Licence for 10 Little Newport Street.

As a responsible authority under section 13 (4) of the Licensing Act 2003 as amended under the Police and Social Responsibility Act 2011, the Licensing Authority have considered your application in full. The Licensing Authority has concerns in relation to this application and how the premises would promote the Licensing Objectives:

- Public Nuisance
- Prevention of Crime & Disorder
- Public Safety
- Protection of children from harm

The premises is located within the West End Cumulative Impact area and as such various policy points must be considered, namely CIP1 and OS2.

This application seeks to permit the sale of alcohol for consumption off the premises for the following times:

| Monday to Saturday: | 10:00 to 23:00 |

Paragraph 2.5.26 of the Council's Statement of Licensing Policy 2016 states that "the council is concerned that alcohol loading from off licence sales is a significant problem in the West End and adversely affects the licensing objectives". The Licensing Authority acknowledges that the applicant has agreed conditions that go some way in mitigating the potential adverse effects on the licensing objectives, however the applicant must also demonstrate that they will not add to cumulative impact in the Cumulative Impact Areas. Unless the applicant can satisfy the concerns of the Licensing Authority by demonstrating that the application will not add to cumulative impact if granted it will be for Licensing Sub-Committee Members to determine this application given its location within the West End Cumulative Impact area.

Please accept this as a formal representation.

Further correspondence from the Applicant to the Licensing Authority was received on 09 July 2018:

Mr. Koduah came to visit the premises last Thursday and agreed that there were no concerns regarding your concerns listed below i.e..

- Public Nuisance Customers are more likely to be passer-by or tourists, who will not lead to an overall increase of such problems.
- Prevention of Crime & Disorder *it will not lead to an increase in alcohol consumption. Therefore problems will not arise.*
- Public Safety Public safety remains the same, as the customers will be better spread out in the area with an additional store.

 Protection of children from harm – Children will not be allowed to buy alcohol in our store and we don't envisage such problems with us.

The store will never sell any alcohol to any children as it will be against the law. In any case, most of the children who came to the store were accompanied by adults or parents. So far, I have never had kids coming to my store to ask for alcohol in our current non-licensed status.

An additional store will have a minimal impact on the area or vicinity as the overall number of drinkers will still remain the same. If they cannot find a licensed store in our street, they can or will easily find another one nearby. In any event, I have more tourists than local customers frequenting our store. The volume of customers will not increase, but merely spread out as a result of an additional store.

My store is too small and basic to have any impact on the concerns you have stated. It will not be a tourist attraction; just a simple store catering for the needs of the passer-by and tourists.

Accordingly, I trust you will withdraw your representation and grant me the licence as applied.

Further correspondence from the Licensing Authority to the Applicant dated 12 July 2018

Thank you for email relating to the points raised in the Licensing Authority's representation to your application. I have taken all of your points on board and note the intended operation of the premises and target audience that you have outlined below.

However, as this application is located within the West End Cumulative Impact Area, it will be for our Licensing Sub-Committee Members to determine whether you have demonstrated accordingly that the application will not add to cumulative impact in the cumulative impact area.

Further correspondence from the Applicant to the Licensing Authority was received on 12 July 2018:

Thank you for your response. May I add that the alcohol sales will only be a small proportion of the overall business. Currently, the turnover is very small and not viable for the excessive rent and rates paid in maintaining such a business. Because the store is very small, there is a limitation on the growth of the business. As I had said in my previous email, any adverse effect on granting on the licence will be **NEGLIGIBLE**. Mr. Koduah had been to the premises and can brief you on the location and size of the premises. There are many licensed outlets surrounding the area and an additional outlet will not affect the overall usage, as such consumers will simply be diluted and spread out amongst the outlets. Even Leicester Tube has a licensed outlet, and together with other nearby outlets would have taken away most potential consumers away from my premises.

I hope the committee will take this and other points into consideration

I refer to the application for a new Premises Licence for the above mentioned premises. These premises are located within the West End Cumulative Impact area. I have considered the information that you have provided within and accompanying this application. I have also considered the application in line with the relevant policies within the Councils Statement of Licensing Policy dated January 2016.

The applicant is seeking to:

 Supply alcohol for the consumption "Off" the premises at the following times: Monday to Saturday: 10:00 to 23:00 hours Sunday: 10:00 to 22:30 hours

Following consideration of the application and how it may affect the Licensing Objectives and meeting the requirements of the Council's Statement of Licensing Policy I wish to make the following representations:

1. The hours requested to supply alcohol may have the likely effect of increasing Public Nuisance and impact on Public Safety within the West End Cumulative Impact area

The applicant has provided conditions in support of the application. These are being considered but they do not fully address the concerns of Environmental Health. Additional conditions may be proposed.

It is my view that there is insufficient information to address the concerns of Environmental Health and the granting of this application as presented would have the likely effect of causing an increase in Public Nuisance and may affect Public Safety within the West End Cumulative Impact area

The applicant is asked to contact the undersigned to arrange a site visit to assess the premises to ensure the premises is satisfactory and following this, additional conditions may be recommended by Environmental Health to support the licensing objectives Prevention of Public Nuisance and Public Safety.

Following the proposal of conditions that the applicant has agreed, Environmental Health have withdrawn their representation. The agreed conditions can be found at Appendix 4 of the report.

I have looked through the application and would like to try and arrange a meeting with you at the venue to discuss this fully and then try and propose some conditions for your application.



On 30 July 2018 the Applicant sent the following email to the Licensing Service:

Dear Shannon Pring,

Thank you for your email dated 24/7/2018 and the attachments which highlights representations from the police and the Environment Health Officer, Mr Maxwell O. Koduah.

I believe that a hearing is no longer necessary for the reasons set out below.

i) Representations from the Environmental Health Officer Mr Maxwell O. Koduah dated the 27th June 2018:

M Maxwell O. Koduah had visited my premises in July to discuss my applications and his concerns; in particular condition 1 and 8. I have agreed to all his conditions in my email to him dated 11th of July 2018. Please find attached emails between me and Mr Robert O. Koduah.

ii) CIP 1 - I believe the cumulative impacts on the environment and vicinity came from all the clubs, pubs, discos. music venues and fast food outlets nearby. Mine is just a small convenient store

and would not have any cumulative impact on the surroundings that would affect the public safety and health. The CIP 1 should not apply to me.

iii) O2 - I can confirm that the police have withdrawn their representations on this issue. I have been in touch with them by email and i attached the email correspondence between myself and the police dated the 21at and 25th of June 2018.

You would note from their email to me on the 25th of June 2018 that they had agreed to withdraw their representations as I had accepted and agreed to all their conditions.

I attach my response to an email from Daisy Gadd dated the 9th of July 2018 addressing the Licensing Objectives therein.

I therefore believe that all outstanding issues and representations from the relevant authority have been resolved and t is not necessary for me to attend the hearing. Please forward my response to the attention of the hearing licence committees.

Thank you for your assistance and i await a favourable response.

Attached to the above email was the applicant response to the Licensing Authority representation:

Licensing Objectives:

1) Public Nuisance

Pre-existing drinking, anti-social or environmental problems in the area, including any increase, should not be held against my application. These problems have always been there.

My trading premises are small and it is unlikely to cause an incremental increase of such problems as it is not one which will attract drinkers; unlike pubs, night clubs or fashionable joints. It would not be right to consider my applications along with these pubs; clubs; nightclubs and discos that have huge venues or premises.

Most of the passer-by along Little Newport St are usually Chinatown shoppers, restaurant goers or just passing through. They are unlikely to stop for an alcoholic drink when there are posh pubs or clubs along the way. By the time they leave such joints, it will be late in the evening, and beyond the proposed licensing hours.

They are the ones most likely to cause anti- social behaviour or environmental problems. In any event, I have had experiences in the past dealing with such problems as I used to run two restaurants years ago and had encountered potential trouble makers, refused to sell to children, after licensing hours or to those who appeared intoxicated.

The Police have no objection to the application and withdrawn their representation; a copy of their email attached.

2) Prevention of Crime & Disorder

We will have a system in place which ensures that alcoholic drinks are only sold to responsible adults. Any member of the public who appear intoxicated or likely to cause problems with further consumption of such drinks will be denied services.

We will ensure that a system is in place to ensure that children will not be sold alcohol and identification verification will be required for those who appear age 25 or below.

The alcoholic drinks will be kept in secured cupboards behind the counter, where customers would be able to access. These cupboards will be kept locked during off-license hours.

We have a 24-hour CCTV system to monitor potential troublemakers, both inside the outside the premises. We will also keep a log of incidents within the premises.

Opening and closing times of licensing hours will be prominently displayed on the shop front and in front of the counter. Posters on responsible and safe drinking will also be displayed.

The Police and the Environmental Health Officers have issued conditions which we have accepted.

3) Public Safety

We will ensure that the sale of alcohol will not endanger Public Health and Safety. As soon as someone or a potential group is suspected of causing trouble, we will cease all alcohol sales, until the potential threat is eliminated. The safety of the staff and public are paramount.

4) Protection of children from harm -- age verification policy

As stated in Para (2) above, no one under the age of 18 will be served and age and identity verification will be demanded if someone appears to be 25 or below. Sales will be refused to any adult who appears to be buying such drinks for a minor

Opening and closing times of licensing hours will be prominently displayed on the shop front and in front of the counter.

5) Protection of environment

Prominent sign regarding the proper disposal of used cans or bottles into the numerous recycle bins, around the vicinity.

6) Will not add to cumulative impact in the Cumulative Impact area.

Pre-existing drinking, anti-social or environmental problems in the area, including any increase, should not be held against our application. These problems have always been there.

It is unlikely that our small unit can or will cause an incremental increase of such problems as it is not one which will attract drinkers; unlike pubs, night clubs or fashionable joints. If any, it will be negligible as we are a very small unit. The most likely scenario will be to dilute the customer base across such shops in the area.

Most of the passer-by along Little Newport St are usually Chinatown shoppers, restaurant goers or just passing through. They are unlikely to stop for an alcoholic drink when there are posh pubs or clubs along the way. By the time they leave such joints, it will be late in the evening, and beyond our proposed licensing hours.

They are the ones most likely to cause anti- social behaviour or environmental problems. In any event, I have had experiences in the past dealing with such problems as I used to run two restaurants years ago and would refuse services to potential trouble makers, children, after licensing hours or to those who appeared intoxicated.

I would invite the Council to take the above representations into account and approve my application for a licence accordingly. Please do not hesitate to contact me if the committees have any further queries.

Premises History

There is no licence or appeal history for the premises.

CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE AND CONDITIONS PROPOSED BY A PARTY TO THE HEARING

When determining an application for a new premises licence under the provisions of the Licensing Act 2003, the licensing authority must, unless it decides to reject the application, grant the licence subject to the conditions which are indicated as mandatory in this schedule.

At a hearing the licensing authority may, in addition, and having regard to any representations received, grant the licence subject to such conditions which are consistent with the operating schedule submitted by the applicant as part of their application, or alter or omit these conditions, or add any new condition to such extent as the licensing authority considers necessary for the promotion of the licensing objectives.

This schedule lists those conditions which are consistent with the operating schedule, or proposed as necessary for the promotion of the licensing objectives by a responsible authority or an interested party as indicated. These conditions have not been submitted by the licensing service but reflect the positions of the applicant, responsible authority or interested party and have not necessarily been agreed

Mandatory Conditions

- 1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
- 2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
- 3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
- 4. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- 5(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 5(ii) For the purposes of the condition set out in paragraph 5(i) above -

- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula -

P = D+(DxV)

Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 5(iii). Where the permitted price given by Paragraph 5(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 5(iv). (1) Sub-paragraph 5(iv)(2) below applies where the permitted price given by Paragraph 5(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Conditions consistent with the operating schedule

- 6. The premises shall only sell alcohol in complete bottles or cans and not open or break them up to sell as individual 'shots' etc.
- 7. The premises shall not allow credit to customers to encourage them to consume alcohol.
- 8. The premises shall strictly observe the licensing opening and closing hours each day and to display a prominent sign stating that it is illegal to sell alcohol to under 18.

Conditions proposed by the Environmental Health and agreed by the Applicant to form part of the operating schedule

- 9. All tills shall automatically prompt staff to ask for age verification identification when presented with an alcohol sale.
- 10. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and leave the area quietly.
- 11. No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
- 12. All waste shall be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times
- 13. No waste or recyclable materials, including bottles, shall be moved, removed from or placed in outside areas between 23:00 hours and 08:00 hours on the following day
- 14. No deliveries to the premises shall take place between 23:00 hours and 08:00 hours on the following day.
- 15. A direct telephone number for the manager at the premises shall be publicly available at all times the premises is open. This telephone number is to be made available to residents and businesses in the vicinity
- 16. Outside of the hours authorised for the sale of alcohol and whilst the premises are open to the public, the licence holder shall ensure that all alcohol within the premises (including alcohol behind the counter) is secured in a locked store room or behind locked grilles, locked screens or locked cabinet doors so as to prevent access to the alcohol by both customers and staff.
- 17. During the hours of operation of the premises, the licence holder shall ensure sufficient measures are in place to remove and prevent litter or waste arising or accumulating from customers in the area immediately outside the premises, and that this area shall be swept and or washed, and litter and sweepings collected and stored in accordance with the approved refuse storage arrangements by close of business.


Conditions proposed by the Police and agreed by the Applicant to form part of the operating schedule

- 18. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31 day period.
- 19. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested

- 20. There shall be a personal licence holder on duty on the premises at all times when the premises are authorised to sell alcohol.
- 21. No super-strength beer, lagers, ciders or spirit mixtures of 5.5% ABV (alcohol by volume) or above shall be sold at the premises, except for premium beers and ciders supplied in glass bottles.
- 22. There shall be no self service of spirits on the premises.
- 23. Prominent signage indicating the permitted hours for the sale of alcohol shall be displayed so as to be visible before entering the premises, where alcohol is on public display, and at the point of sale
- 24. A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 25. A record shall be kept detailing all refused sales of alcohol. The record should include the date and time of the refused sale and the name of the member of staff who refused the sale. The record shall be available for inspection at the premises by the police or an authorised officer of the City Council at all times whilst the premises is open
- 26. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police. It must be completed within 24 hours of the incident and will record the following:
 - (a) all crimes reported to the venue
 - (b) all ejections of patrons
 - (c) any complaints received concerning crime and disorder
 - (d) any incidents of disorder
 - (e) all seizures of drugs or offensive weapons
 - (f) any faults in the CCTV system, searching equipment or scanning equipment
 - (g) any refusal of the sale of alcohol
 - (h) any visit by a relevant authority or emergency service.
- 27. All sales of alcohol for consumption off the premises shall be in sealed containers only, and shall not be consumed on the premises.
