The licence is held by Greene King Brewing & Retailing Limited under reference number 22/07315/LIPVM.				
Preliminary Note:	During the consultation period, the Premises Licence Holder submitted a minor variation application to add proposed Model Condition 64 to the premises licence which has addressed the applicants concerns regarding deliveries to the Premises at restricted times. Model Condition 64 (MC64) states:  "No deliveries to the premises shall take place between (23:00) and (07:00) hours an the following dov"				
	on the following day"  With MC64 now having been agreed the applicant has confirmed that he no longer wishes to take part in the review. The review is now proceeding based on the representations received from three interested parties, namely a local resident, business owner and Local Ward Councillor Karen Scarborough citing nuisance as an ongoing concern thus failing to promote the prevention of public nuisance licensing objective				

# 2. SUMMARY OF APPLICATION

- 2.1 An application submitted by Mr Michael Zelouf for a review of the premises licence in respect of the Globe Public House, 43-47 Marylebone Road, London NW1 5JY was received by the Licensing Authority on the 13 July 2022 on the grounds of Prevention of Public Nuisance. Please see Appendix 1. The Premises are in close proximity to residential properties with a resident count of 146.
- 2.2 Home Office Guidance issued under section 182 of the Act (Para 11.2) states that at any stage following the grant of a premises licence, a responsible authority, such as the Police or the Environmental Health Service, or any other person who can seek a review, may ask the Licensing Authority to review the premises licence because of a matter arising at the premises in connection with any of the four licensing objectives.
- 2.3 As such, in accordance with section 52(2) of the Act, the Licensing Authority must hold a hearing to consider the application and any relevant representations and take whatever appropriate action as specified below in paragraph 4 to safeguard the promotion of the licensing objectives.

- 2.6 These review proceedings are brought under the licensing objectives on the grounds of Prevention of Public Nuisance. A complaints history of the Premises has been provided by the Environmental Health Service and can be found at **Appendix 5.1**

# 3. REPRESENTATIONS:

- 3.1 The application has received a representation in support of the review from the Environmental Health Service on 28 July 2022 on the grounds of Prevention of Public Nuisance and can be found at **Appendix 5.**
- 3.2 The application has also received representations in support of the review from three interested parties mainly on the grounds of public nuisance and crime and disorder and can be found at **Appendix 6.** However, following the proposed addition of MC64 to the licence the Local Ward Councillor has withdrawn her representation.

# 4. POWERS OF THE SUB-COMMITTEE WHEN DETERMINING THE APPLICATION:

- 4.1 The Authority must, having regard to the application and the representations, take such steps (if any), as it considers appropriate for the promotion of the licensing objectives. The steps are:
  - (a) to modify the conditions of the licence;
  - (b) to exclude a licensable activity from the scope of the licence;
  - (c) to remove the designated premises supervisor:
  - (d) to suspend the licence for a period not exceeding three months;
  - (e) to revoke the licence:
  - and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition added.
- 4.2 In accordance with section 52(6) of the Act, if the authority takes measures to modify conditions or exclude licensable activities from the licence, it may stipulate that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.
- 4.4 The licensing authority's determination of this application does not have effect until the 21 day appeal period has expired or if the decision is appealed the date the appeal is determined and / or disposed of.

# 5. LICENSING ACT 2003 APPLICATIONS AND APPEAL HISTORY

- 5.1 Any applications under the Licensing Act 2003 are set out in **Appendix 7.**
- 5.2 The chronology relating to appeals and applications is set out in **Appendix 7.**

# 6. Equality Implications

The Council in its capacity as Licensing Authority has a duty to have regard to its public sector equality duty under section 149 of the Equality Act 2010. In summary, section 149 provides that a Public Authority must, in the exercise of its functions, have due regard to the need to:

- (a) eliminate discrimination harassment, victimisation and any other conduct that is prohibited by or under this Act;
- (b) advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it; and
- (c) foster good relations between persons who share a relevant protected characteristics and persons who do not share it.

Section 149 (7) of the Equality Act 2010 defines the relevant protected characteristics as age, disability, gender reassignment, Marriages and Civil Partnerships, pregnancy and maternity, race, religion or belief, sex, and sexual orientation.

My bedroom is on the same road junctions as the pub i.e. the corner of Marylebone Road and Baker Street. The pub does at least 2 deliveries per week to replace empty barrels with full barrels, which they tell me they have to do before 7am as the road is a double red route and any later will prevent them from delivering goods.

The issue started many years ago when the pub moved to using metal aluminium barrels. These barrels ping like a bell when either two barrels have contact, or when the barrel connects with a hard surface.

In my opinion, the premises takes in circa 50-100 barrels per delivery and by default removes circa 50-100 barrels per delivery and I have many photographs to demonstrate. As you can appreciate there is a lot of opportunity for noisy contact and in my experience, when I get woken up by the noise I can't immediately fall asleep, because of the frequent level of pings over a 45 minute period, whilst the delivery is in progress. In the latest delivery live seen the barrels piled up on top of each other with the top barrel placed on its side. I saw that top barrel roll and ping when it had contact with a hard surface, which in this case was the railings to the underpass.

I've pleaded with the pub owners to rubberise the barrels so they become noise cancelling, even going as far as to find a company that could produce rubberised sleeves, however the pub group has rejected this as a solution, without even accepting my research, claiming it's not operationally viable. When pushed they refuse to answer why it's not operationally viable.

They claim they have instructed their drivers to be more careful, but this is not a long terms solution and having had time to observe, even with this increased scrutiny, it's not working. There is still noise and under human rights law I have the right to a full night's sleep which the pub is denying me on a regular basis.

During my last communications with Ricardo in the WCC noise team, it was suggested that that the pubs licence is reviewed as it's not reasonable to make any undue noise before 7am and that a licence review can place restrictions on deliveries before 7am. As such I would be keen to open up such a review.

Correspondence of complaints listed with the Licensees owners (including contemporaneous emails before 7am) together with photos and complaint references to WCC noise team can be provided.

I note live had Westminster's Citizen Advice Bureau trying to resolve this in 2015, with complaints being made to my local councillors and Westminster Licencing. I recorded a number of pre 7am deliveries before 7am in email complaints.

More recently I reached out to Greene King on 3 March 2022 for a solution and received a response from the solutions team on 31 March 2022 stating that because the pub is on a red route the delivery must be done between 5 and 7am.

Since 1 April 2002 Ive recorded some of the deliveries that woke me up in emails and photographs, however these are not all the incidents as Ive also tried to sleep through them:

# Annex 1 - Mandatory conditions

- 1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
- 2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
- 3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
- 4. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
  - games or other activities which require or encourage, or are designed to require or encourage, individuals to:
    - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
    - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise antisocial behaviour or to refer to the effects of drunkenness in any favourable manner;
  - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
    - (a) a holographic mark, or
    - (b) an ultraviolet feature.

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
  - (i) beer or cider: ½ pint;
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

- 8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 8(ii) For the purposes of the condition set out in paragraph 8(i) above -
  - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - (b) "permitted price" is the price found by applying the formula -

P = D + (DxV)

Where -

- (i) P is the permitted price.
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
  - (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

- 8(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 8(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Conditions which reproduce the effect of any restriction imposed on the use of the premises by specified enactment

9. The terminal hour for late night refreshment on New Year's Eve is extended to 05:00 on New Year's Day.

# Annex 3 - Conditions attached after a hearing by the licensing authority

# 11. (i) For the First Floor only:

Alcohol shall not be sold, supplied, consumed in or taken from the premises except during permitted hours.

In this condition, permitted hours means:

- (a) On weekdays, other than Christmas Day, Good Friday or New Year's Eve, 10:00 to 23:00:
- (b) On Sundays, other than Christmas Day or New Year's Eve, 10:00 to 22:30;
- (c) On Good Friday, 12:00 to 22:30;
- (d) On Christmas Day, 12:00 to 15:00 and 19:00 to 22:30:
- (e) On New Year's Eve, except on a Sunday, 10:00 to 23:00;
- (f) On New Year's Eve on a Sunday, 12:00 to 22:30;
- (g) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).
- (ii) Alcohol may be sold or supplied for one hour following the hours set out above (other than Christmas Day and New Year's Eve), and on Christmas Day, between 15.00 and 19.00, to persons taking table meals in the premises in a part of the premises usually set apart for the service of such persons and for consumption by such a person in that part of the premises as an ancillary to his meal. For other purposes or in other parts of the premises the hours set out above shall continue to apply.

# NOTE - The above restrictions do not prohibit:

- (a) during the first thirty minutes after the above hours the consumption of the alcohol on the premises;
- (b) during the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
- (c) during the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking table meals there if the alcohol was supplied for consumption as ancillary to the meals;
- (d) the sale or supply of alcohol to or the consumption of alcohol by any person residing in the licensed premises;
- (e) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered:
- (f) the sale of alcohol to a trader or registered club for the purposes of the trade or club;
- (g) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
- (h) the taking of alcohol from the premises by a person residing there;
- (i) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied;
- (j) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

In this condition, any reference to a person residing in the premises shall be construed as including a person not residing there but carrying on or in charge of the business on the premises.

# 12. For the Ground Floor only:

Alcohol shall not be sold, supplied, consumed in or taken from the premises except during permitted hours.

In this condition, permitted hours means:

- (a) On Mondays to Thursdays, 10:00 to 23:30:
- (b) On Fridays to Saturdays, 10:00 to 00:00;
- (c) On Sundays, 10:00 to 22:30;
- (d) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).

NOTE - The above restrictions do not prohibit:

- (a) the sale or supply of alcohol to or the consumption of alcohol by any person residing in the licensed premises;
- (b) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- (c) the sale of alcohol to a trader or registered club for the purposes of the trade or club;
- (d) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
- (e) the taking of alcohol from the premises by a person residing there;
- (f) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied;
- (g) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.


In this condition, any reference to a person residing in the premises shall be construed as including a person not residing there but carrying on or in charge of the business on the premises.

- 13. To extend the hours for all licensable activities on the ground floor by one hour for St David's Day, St Patrick's Day, St George's Day and St Andrew's Day with seven days notice to the Police.
- 14. To extend the hours for all licensable activities on the ground floor by one hour for statutory Bank Holiday weekends (Friday to Monday), the Thursday before Good Friday and Christmas Eve save and except for Bank Holiday Monday.
- 15. Regulated Entertainment in the form of Live Music shall be limited to two performers at any one time.
- 16. Customer to be presented with an itemised bill showing the details of all alcoholic drinks purchased, if payment is made by credit or debit card.
- 17. The full menu shall be available throughout the trading day until 22:00.
- Other than in the areas designated for drinking, or under any other authorization, no persons shall be permitted by the designated premises supervisor or persons acting under his/hers authorization to remove alcohol from the premises in an open container.

- 19 The Designated Premises Supervisor will ensure that the premises is signed up to any Pubwatch or other related scheme.
- The Designated Premises Supervisor or a member of staff authorised by him shall attend Pubwatch meetings or any related scheme on a regular basis.
- Any special events at the Premises will be properly risk assessed and appropriate additional measures taken by the Designated Premises Supervisor to ensure that the event is properly managed. A copy of any risk assessment document will be made available to the police at reasonable request.
- The Designated Premises Supervisor or a member of staff nominated for the purpose shall ensure that any radio link system used by the premises is in operating order and shall notify any faults to the suppliers as soon as practicable.
- 23 All certificates listed below shall be submitted to the Local Authority upon written request:
  - i) Any emergency lighting battery or system;
  - ii) Any electrical installation;
  - iii) Any emergency warning system.
- No noise shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
- A sound insulation scheme which has been designed by a competent acoustic consultant and approved by the Pollution Control Division of the Environmental Department shall be maintained to contain noise within the curtilage of the premises to a reasonable degree to ensure no disturbance to residents in the immediate vicinity.
- The Designated Premises Supervisor or a member of staff nominated for the purpose shall ensure that prominent, clear and legible notices are displayed at all exits requiring customers to respect the needs of local residents and to leave the area quietly prior to opening for trading.
- No rubbish including bottles will be moved, removed or placed in outside areas between 23:00hrs and 08:00hrs.
- 27 Late night refreshment is restricted to consumption on the premises.
- The Premises shall operate a 'Challenge 21' policy and appropriate signage shall be displayed prominently in the premises.
- AWP machines will be placed in such areas as to be clearly visible from the bar area and supervised by staff members. Staff will be trained in their responsibility to supervise the machines at all times.
- 31 No striptease, no nudity and all persons on the premises to be decently attired at all times.
- Any entertainment, performance, service, or exhibition involving nudity or sexual stimulation which would come within the definition of a sex establishment in Schedule 3 to the Local Government (Miscellaneous Provisions) Act 1982 as amended by the Greater London Council (General Powers) Act 1986 (whether or not locally adopted), shall not be provided.
- 33. The venue shall install and maintain a comprehensive CCTV system as per the minimum requirements of a Metropolitan Police Crime Prevention Officer. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the venue is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available immediately upon the request of Police or authorised officer throughout the preceding 31 day period.
- 34. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member shall be able to show Police recent data or footage with the absolute minimum of delay when requested.
- 35. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police, which will record the fallowing:

- (a) all crimes reported to the venue;
- (a) an crimes reported to the vertue;(b) any complaints received regarding crime and disorder;(c) any incidents of disorder;(d) any faults in the CCTV system;

- (e) any refusal of the sale of alcohol;
- (f) any visit by a relevant authority or emergency service.
- 36. There shall be no sale of alcohol for consumption off the premises after 23:00 hours.
- 37. Alcohol being consumed outside the premises shall cease at midnight on Monday to Saturday.


