Premises licence history:	The premises has held a premises licence since at least conversion in 2005. The current licence holder has held the premises licence during that time. This is the first application to alter the premises licence since it was first granted.
Applicant submissions:	The applicant has stated the following in their operating schedule:
	Supervision of licensed activities by designated premises supervisor and other suitably trained individuals. The designated premises supervisor will continue to supervise the supply of alcohol for consumption off the premises (i.e. Christie's wine auctions) in his capacity as International Head of Christie's Wine Department. He will delegate the supervision of the supply of alcohol for consumption on the premises to suitably trained individuals being designated Christie's employees and/or the representatives of Christie's catering sub-contractor William Norris Ltd.
	Christie's has appropriate security systems and security personnel operating at the premises 24 hours a day, to protect both property and people. The security personnel are all SIA licensed.
	The security team conduct an event risk review for each event to determine if the activities at the event, the volume of guests, the value or type of property or other factors require enhanced security. As well as monitoring security within the premises, they also monitor security around the perimeter of the premises (for example when guests arrive at or leave an event) to ensure no crime or disorder.
	As the premises are private property Christie's has the right to refuse entry to those it considers a danger or a nuisance, or ask them to leave. These rights are expressly reserved in our auction conditions, and in our event hire terms and conditions.
	Most events where alcohol is served are by invitation only with a pre-determined guest list. There may occasionally be late night openings or public art fairs where the premises are open to the general public and alcohol is served, but these would be very limited in number.

To minimise the risk of disorder, alcohol is only served inside the building. It will not be served to those who are under age or who appear to be intoxicated. Individuals in Christie's events team have attended training for and passed the Level 2 Award for Personal Licence Holders. Christie's catering sub-contractor, William Norris Ltd, has also conducted suitable training for those staff deployed at Christie's premises.

Christie's has security personnel on the premises 24 hours a day to ensure the safety and security of those on the premises.

Christie's has conducted a general risk assessment to identify and mitigate health & safety related risks relating to the premises. The Events team has also conducted a risk assessment in relation to conducting event activities at the premises. The Security team conducts an event by event risk assessment and monitors the number of attendees during the event to ensure that safe levels are not exceeded.

All relevant Christie's personnel have completed Health and Safety training, and an appropriate proportion of individuals have first aid and defibrillator training.

Christie's catering contractor, William Norris Ltd, which serves the alcohol for on premises consumption and provides other catering services, has also carried out a risk assessment in relation to its activities at the premises and appropriately trained its personnel on both health and safety issues and alcohol licensing. In the event of an accident, Christie's has public liability insurance up to a level of £10million.

Alcohol will only be served inside the premises. Those supervising an event and those serving alcohol have been trained to not serve alcohol to individuals who already appear to be intoxicated.

Films and music will only be played inside the premises and the volume will be kept at a level so that it is not audible outside the premises.

Children are not generally present at events where alcohol is served or other licensable activities take place. Most events where alcohol is served are by invitation only with a pre-determined adult guest list.

There may occasionally be Late Night Openings or Public Art Fairs where the premises are open to the general

public and alcohol is served. These events are limited in number and to the extent that members of the public bring their children, William Norris' employees have been trained to adopt a 'challenge 25' system (their staff are advised to request ID from anyone they feel does not fit this criteria, and there is a 'challenge 25' poster on display throughout the events).
Following discussions with Environmental Health and the Police, the applicant has proposed an additional 15 conditions to be added to the licence should the application be successful (see <b>Appendix 4</b> ). On this basis, Environmental Health withdrew their representation.

#### 1-C Layout alteration

Previously licensable activities were restricted to the ground floor only. The application requests licensable activities take place over the ground, first and second floors (see **Appendix 1**).

#### **1-D** Conditions being varied, added or removed

- Mandatory conditions relating to the on-sales of alcohol and the exhibition of films will be added to the premises licence.
- The following conditions will be added to the premises licence:
  - 1. There shall be no fixed bar at the premises.
  - 2. The licensable activities authorised by this licence and provided at the premises are authorised only for as long as the licence holder's primary day to day business is that of an auction house. For the avoidance of doubt this

condition does not require an actual auction to be happening contemporaneously every time a licensable activity takes place.

- 3. Food and non-intoxicating beverages shall be available in all parts of the premises where alcohol is sold or supplied for consumption on the Premises.
- 4. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and businesses and leave the area quietly.
- 5. No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
- 6. After 23:00 hours or at any time when regulated entertainment takes place, all windows in the immediate vicinity of any regulated entertainment shall be kept closed, and external doors shall also be kept closed except for the immediate access and egress of persons and property.
- 7. Patrons permitted to temporarily leave and then re-enter the premises, e.g. to smoke, shall not be permitted to take drinks or glass containers with them.
- 8. The means of escape provided for the premises shall be maintained unobstructed, free of trip hazards, be immediately available and clearly identified in accordance with the plans provided.
- 9. All emergency doors shall be maintained effectively self-closing and not held open other than by an approved device.
- 10. All emergency exit doors shall be available at all material times without the use of a key, code, card or similar means.
- 11. The approved arrangements at the premises, including means of escape provisions, emergency warning equipment, the electrical installation and mechanical equipment, shall at all material times be maintained in good condition and full working order.
- 12. A Challenge 21 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 13. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings of






