Title: Nomination and Appointment of Local Authority School Governors

1. Executive Summary

- 1.1 The Cabinet Member for Education approved the revised arrangements for the nomination and appointment of local authority School Governors.
- 1.2 The Panel referred to has now met to consider nominated governors and the Panel's recommendations are set out in Appendix A. The Panel has given careful consideration to the nominations making sure in each case that the recommended nominee best meets the requirements of the schools governing body.
- 1.3 The Panel is a non-decision-making advisory body and makes recommendations to the Cabinet Member for Economic Development, Education and Skills, who then makes the formal decision to nominate or appoint the respective local authority Governor.

2. Recommendations

- 2.1 That Appendix A to this report be exempt from public disclosure by virtue of paragraph 1 of Schedule 12a of the Local Government Act 1972 (as amended) – Information Relating to a Particular Individual.
- 2.2 That the recommendations of the Local Authority School Governor's Advisory Panel set out in Appendix A be approved.

3. Reasons for Decision

- 3.1 Every maintained school governing body must contain at least one Local Authority nominated school governor.

4. Background Information

- 4.1 Every maintained school governing body must contain at least one Local Authority (LA) Governor. Academies may choose whether to include an LA Governor in their arrangements.
- 4.2 For Schools constituted under the School Constitution (England) Regulations 2012 the Local Authority must nominate a person as the Local Authority governor and it is for the school to appoint that person.
- 4.3 Since 1 September 2015 all maintained schools have been constituted under the 2012 Regulations. Appointments of Local Authority Governors will be made by the respective governing bodies following a nomination by the Cabinet Member for Economic Development, Education and Skills.
- 4.4 The Cabinet Member for Education approved revised arrangements for the appointment of Local Authority nominated School Governors.
- 4.5 The Panel has considered the nominations and its recommendations are set out in Appendix A. The Panel has had regard to the needs of each school governing body in making its recommendations.
