



LICENSING SUB-COMMITTEE HEARING

STANDING ORDER OF PROCEEDINGS :

At the beginning of the hearing the procedure that will be followed will be explained to the parties. The hearing will so far as is possible, take the form of a discussion, led by the Sub-Committee. Cross-examination will not be permitted unless the Sub-Committee considers it necessary.

1. INTRODUCTION BY CHAIRMAN

2. INTRODUCTION OF THE APPLICATION BY AN OFFICER OF THE LICENSING SERVICE.

3. REQUESTS BY A PARTY FOR ANY OTHER PERSON TO APPEAR AT THE HEARING

In accordance with the Council's Rules of Procedure. Such permission will not be unreasonably withheld provided a proper notice has been given.

4. A SUMMARY OF THE NATURE AND EXTENT OF THE APPLICATION BY THE APPLICANT OR THEIR REPRESENTATIVE.

This should be brief, avoid repetition of material already made available to the Committee in the Officer's report or otherwise, and include any reasons why an exception should be made to the Council's Licensing Policy, where appropriate. That will be followed by the evidence of any person who has been given permission by the Panel to give supporting evidence on behalf of the applicant.

5. A SUMMARY OF THE REASONS FOR REPRESENTATIONS ON THE APPLICATION BY ANY OBJECTORS

This should be brief and avoid any repetition of information already made available to the Committee either in the Officer's report or otherwise. That will be followed by the evidence of any person who has been given permission by the Panel to give supporting evidence on behalf of the objectors.

6. DECISION

The authority must make its determination at the conclusion of the hearing.
