## 1. Background Information

- 1.1 Ward budgets were established under the City Council's Neighbourhood Programme agreed by the Cabinet in November 2007.
- 1.2 The programme enables ward members to fund projects in the local area which benefit residents of that area and/or meet local priorities.
- 1.3 £46,000 is provided to each ward in each financial year of a 4-year electoral cycle. Monies not spent in year roll-over to the next until the end of the cycle.
- 1.4 Budget provision for the financial years 2018 to 2022 equates to £184,000 per ward
- 1.5 All decisions on projects to be funded are made by the ward members from the wards concerned, to support their local priorities.

## 2. Proposed Projects

- 2.1 £11,681.61 will fund The Spring Leicester Square CIC's provision of counselling which will be offered to people in the local community who are marginalised or on the fringes of society. This includes rough sleepers, homeless people, and those effected by addictions and mental health difficulties, as well as care leavers and ex-offenders, who are unable to access services due to circumstances or financial difficulties. With this funding, The Spring can offer 276 1-2-1 counselling sessions during the period and 12 group therapy sessions.

## 3. Financial Implications

- 3.1 Expenditure and approvals in process from the Marylebone High Street budget to date total £181,796.26 leaving **£2,203.74** to be allocated.
- 3.2 The proposals for expenditure in this report amount to **£683.16** and leaves **£1,520.58** available for future allocation.
- 3.3 Expenditure and approvals in process from the St James's budget to date total £150,614.08 leaving **£33,385.92** to be allocated.
- 3.4 The proposals for expenditure in this report amount to **£8,499.60** and leaves **£24,886.32** available for future allocation.
- 3.5 Expenditure and approvals in process from the Vincent Square budget to date total £123,416.19 leaving **£60,583.81** to be allocated.
- 3.6 The proposals for expenditure in this report amount to **£499.50** and leaves **£60,084.31** available for future allocation.

- 3.7 Expenditure and approvals in process from the West End budget to date total £169,755.02 leaving **£14,244.98** to be allocated.
- 3.8 The proposals for expenditure in this report amount to **£1,999.35** and leaves **£12,245.63** available for future allocation.
- 3.9 This report approves the release of the above funding from the ward budget(s) as listed above. The individual decisions taken on the projects being funded are made by the ward members for the ward(s) involved.

#### **4. Legal Implications**

- 4.1 Section 1 of the Localism Act, aka “the general power of competence” enables authorities “to do anything that individuals generally may do”. The proposals within this report are consistent with the Council exercising this power.

#### **5. Consultation**

- 5.1 The proposals have been approved by all Councillors, or a majority of Councillors from all wards involved
- 5.2 The proposal for Counselling and Psychotherapy has been drawn up by the Councillor and Governance Support Officer with The Spring Leicester Square CIC, the financial and legal aspects of the funding have been verified by the Council’s Finance and Legal Services Departments.
