Dear all,

I am representing Frank Thaxton at the hearing on Thursday. I may well also be representing Sharon Palazzo, the other objector, but I am just seeking confirmation of this from her.

My clients have been engaging with the mediation facilitated by the Licensing Authority (for which thanks) in the hope of agreeing conditions with the applicant based on what they have been told is the purpose of the application and nature of the operation.

For context, Mr Thaxton and Ms Palazzo both made representations to the previous two applications. They withdrew these representations in each case. This is the third application in a relatively short space of time, and they simply wish to ensure that appropriate conditions constrain the scope of the licence to what is intended.

I have attached the mediation letter forwarded to Mr Thaxton and Ms Palazzo by the Licensing Authority, and the email chain in response where I propose 3 points of amendment on behalf of Mr Thaxton. He has confirmed that he would withdraw his representation should these be accepted. I have not yet had confirmation from Ms Palazzo but I suspect she would withdraw also should these be accepted.

I should be grateful if this email and attachments could be included in the additional documentation.
