#### **Dear Sirs**

I am writing on behalf of the South East Bayswater Residents' Association (SEBRA) to make a relevant representation strongly objecting to this licence variation application on the basis of the likely impact on the licensing objective of 'prevention of public nuisance'.

#### Introduction

SEBRA was formed in 1970 and works to protect the special character of the W2 area. A non-profit, non party-political, voluntary organisation, we represent more than 1,000 people. SEBRA is consulted by Westminster Council on both major developments and all Council activities which affect the daily lives of residents.

As a recognised amenity society we often engage in consultations with licence applicants both before and during the application process and note that we have not been contacted by the applicant in this case.

#### Background

The premises are situated in in a residential and commercial area with shops, restaurants and hotels along Norfolk Place with flats above.

The surrounding area is mostly residential, particularly Star Street, St Michael's Street and adjoining Mews with some smaller budget hotels in Norfolk Square opposite.

#### SEBRA's position

We strongly object to this application, which is to extend hours of 'off sales' of alcohol to midnight Monday to Saturday.

The proposed longer hours are totally against Westminster Council Policy for 'off sales' of alcohol for 'off licence' and 'mini markets' etc.

If these premises were to obtain a later hour for 'off sales' it would open floodgates to other premises to apply to sell alcohol more than the Council's Core Hours policy.

In this particular application, the premises are also situated very close to an area of recognised street drinking and begging particularly in and around Praed Street and Paddington Station.

The premises are situated opposite Norfolk Square where there is a history of young people sitting and drinking on the steps of the small budget hotels or even, illegally, congregating and drinking and making a nuisance in the Council's garden of Norfolk Square, after the garden has closed at dusk.

As the recognised local amenity group, the Hyde Park Estate Association would like to strongly object to the above application to vary the hours for the sale alcohol.

This application is to extend the sale of alcohol: Mon to Sat inclusive 08.00 hours to 00.00 hours (midnight). Sunday unchanged. This is an extension of one more hour every evening from 23.00 hours to 00.00 hours. This application for extended hours is unprecedented as far as we can recall there are no retail sales in this area that have an alcohol licence beyond 23.00 hours. It would set a precedent.

As you will note this area is mainly a residential - one albeit a few other commercial shops. However, anyone who lives locally knows the off licence closes at 23.00 hours and therefore if they wish to purchase alcohol know they have to be there by 23.00 hours.

Therefore, it is our view this would seem likely to become a destination point for non-locals,

hotel visitors, rough sleepers, late night commuters etc. for the sale of alcohol. WCC are aware; as we are about the potential noise that is caused from the sale of late night alcohol and off course with the usual issues of ASB that already exist in this area.

HPEA believe extending this licence to midnight 00.00 will be detrimental to the licensing objectives. Especially: Prevention of crime and disorder; public safety and prevention of public nuisance. It is a difficult task keeping the balancing act keeping both commercial and residential happy. We believe the terminal hour presently of 23.00 hours meets this balance. To extend it beyond this hour would in our view be detrimental to that balance.

We see no possible advantage for a one hour extension to midnight - other than to offer offsales to non locals as stated above - which we believe would be detrimental to the local residential area and would be against Westminster's Licensing Objectives.

We are happy to note Sebra Objections and agree entirely with their comments.

#### 3. Policy & Guidance

The following policies within the City of Westminster Statement of Licensing Policy apply:

## Hours Policy HRS1 applies

- A. Applications within the core hours set out below in this policy will generally be granted for the relevant premises uses, subject to not being contrary to other policies in the Statement of Licensing Policy.

  P. Applications for hours outside the core hours set out in Clause.
- **B.** Applications for hours outside the core hours set out in Clause C will be considered on their merits, subject to other relevant policies, and with particular regard to the following:
- 1. The demonstration of compliance in the requirements of policies CD1, PS1, PN1 and CH1 associated with the likelihood of the effect of the grant of a licence for later or earlier hours on crime and disorder, public safety, public nuisance and the protection of children from harm.
- **2.** If the application is located within a Special Consideration Zone they have demonstrated that they have taken account of the issues identified in that area and provided adequate mitigation.
- **3.** Whether there is residential accommodation in the proximity of the premises that would likely be adversely affected by premises being open or carrying out operations at the hours proposed.
- **4.** The proposed hours of the licensable activities and when customers will be permitted to remain on the premises.
- **5.** The proposed hours when any music, including incidental music, will be played.
- **6.** The hours when customers will be allowed to take food or drink outside the premises or be within open areas which form part of the premises.
- **7.** The existing hours of licensable activities and the past operation of the premises (if any) and hours of licensable premises in the vicinity.
- **8.** Whether customers and staff have adequate access to public transport when arriving at and leaving the premises, especially at night.
- **9.** The capacity of the premises.
- **10.** The type of use, recognising that some venues are more likely to impact the licensing objectives than others; for example, pubs and bars are higher risk than theatres, cinemas and other cultural and sporting venues due to the nature of the operation.
- **11**. The Licensing Authority will take into account the active measures proposed for a 'winding down' period including arrangements for people to be collected from the premises to travel home safely.
- **12**. Conditions on hours may be attached that require that the supply of alcohol for consumption on the premises ceases a suitable period of time before customers are required to leave the premises.
- **13.** The council, acting as the Licensing Authority, may reduce hours if, after review, it is necessary to impose conditions specifying shorter hours in order to promote the licensing objectives.
- **14.** Specific days for non-standard hours should be identified and justified as part of the application to allow responsible authorities and interested parties to evaluate the impact that these licensable activities may have, and to plan accordingly. The consideration of applications for later hours for Bank Holiday Mondays will take into account that later hours are generally granted for preceding

Sundays and that the next day is a working day. Non-specific days are expected to be covered by Temporary Event Notices or variation applications.

**C**. For the purpose of Clauses A and B above, the Core Hours for applications for each premises use type as defined within this policy are:

# 11a. Shops (all licensable activities that are provided as ancillary to the primary use of the premises as a shop except the off sale of alcohol)

Monday to Thursday: 9am to 11.30pm. Friday and Saturday: 9am to Midnight.

Sunday: 9am to 10.30pm.

Sundays immediately prior to a bank holiday: 9am to Midnight.

## 11b. Shops (off-sales of alcohol where it forms either the ancillary

#### or primary use of the premises)

Monday to Saturday: 8am to 11pm.

Sunday: 9am to 10.30pm.

- **D**. Core hours are when customers are permitted to be on the premises and therefore the maximum opening hours permitted will be to the same start and terminal hours for each of the days where licensable activity is permitted.
- **E.** For the purposes of this policy, 'premises uses' are defined within the relevant premises use policies within this statement.

Note: The core hours are for all licensable activities but if an application includes late night refreshment then the starting time for that licensable activity will be 11pm.

## Shops Policy SHP1 applies

- **A**. Applications for a shop outside the West End Cumulative Impact Zone will generally be granted subject to:
- **1.** The application meeting the requirements of policies CD1, PS1, PN1 and CH1.
- **2.** The hours for licensable activities are within the council's Core Hours Policy HRS1.
- **3.** The operation of any delivery services for alcohol meeting the council's Ancillary Alcohol and/or Late-night Refreshment Delivery Service Policy DEL1.
- **4.** The applicant having taken account of the Special Consideration Zone

Policy SCZ1 if the premises are located within a designated zone.

- **5.** The application and operation of the venue meeting the definition of a shop in **Clause C.**
- C. For the purposes of this policy:
- 1. A shop is defined as a stall, vehicle, vessel, temporary structure,

building or part of a stall, vehicle, vessel, temporary structure or building where the primary activity is the sale of goods or services to customers upon payment.

2. The licensable activities for the sale of alcohol for consumption on the premises, regulated entertainment and/or late night refreshment must be ancillary to the primary use of the premises as a shop.

3. The licensable activity of the sale of alcohol for consumption off the premises must be an ancillary function to the primary use of the premises unless that primary use is to sell alcohol for consumption off the premises, e.g. a traditional off licence.

#### 4. Equality Implications

The Council in its capacity as Licensing Authority has a duty to have regard to its public sector equality duty under section 149 of the Equality Act 2010. In summary, section 149 provides that a Public Authority must, in the exercise of its functions, have due regard to the need to:

- (a) eliminate discrimination harassment, victimisation and any other conduct that is prohibited by or under this Act;
- (b) advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it; and
- (c) foster good relations between persons who share a relevant protected characteristics and persons who do not share it.

Section 149 (7) of the Equality Act 2010 defines the relevant protected characteristics as age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, and sexual orientation.



WITNESS STATEMENT OF ASIF GUL

I ASIF GUL of 6 NORFOLK PLACE, LONDON W2 1QN will says as follows:

 I am the owner of my shop situated at 6 Norfolk Place, London W2 1QN. I make this witness statement in support of my application to vary the premises licence. The application proposes to extend the permitted hours for the sale of alcohol from 11pm to midnight on Monday to Saturday.

#### Introduction

2. I am grateful for the opportunity to explain some of my personal background in this witness statement. Various events in my life have been key factors in forming the person that I am today. I hope that by explaining some of my history I can reassure members of the Westminster City Council Licensing Sub-Committee that I am a person that can be trusted to operate my shop professionally and responsibly alongside my neighbours, particularly during the later hours. In doing so, I not only hope to continue to provide for my family and employees, but also provide a valued community shop and proactive presence to help improve the local area.

#### Personal Background

- I was born on in Mazar Sharif, Afghanistan. My father was an officer in the Afghan army. My mother looked after me and my brother and sister at home.
- In 1996, when I was 7, the Taliban began taking control of Afghanistan. My father had to leave our family home suddenly after being identified as a target by the Taliban. I remember the

Taliban breaking down our front door and raiding our house in pursuit of my father after he had left.

- We did not hear from my father for several months. My mother decided to move us to Pakistan. She thought we would all be safer in Pakistan and have a better chance of finding my father.
- 6. When we moved to Pakistan my mother could still not find our father. We had no way of telling whether he was dead or alive. My mother had no work experience. She had only ever looked after us at home. She began begging on the streets in Pakistan to get money to feed us, which was usually only ever one meal a day.
- 7. I cannot remember exactly when, but at some stage a doctor and his family helped my mother by giving her a housekeeping job. The doctor and his family then helped track down my father who had made it safely to the UK. A few months after that, we were able to find a safe way to fly to the United Kingdom and arrived as asylum seekers on 21 August 1999.
- I went to school in Edgware for a short time. Unfortunately, I had a very hard time in school
  and ended up dropping out when I was 12. I then went to help my Uncle in his fish and chip
  shop "Mickey's", which is located just down the road from my shop at 29 Norfolk Place W2
  1QH.
- I was eventually fortunate enough, and extremely grateful, to become a British citizen in 2005.
- 10. A few years later I obtained my private hire driver PCO licence in 2013. I worked as an Uber driver until 2017 before obtaining my heavy goods vehicle driving licence in 2017. I later passed various checks and security clearances to work as a fuel tanker driver and worked during the Covid-19 pandemic delivering fuel on night shifts.
- My father and I both caught Covid-19 in early 2020. We both developed serious symptoms and were treated on the same ward in Luton and Dunstable University Hospital. Sadly, my

father died of Covid-19 on 5 April 2020. I was fortunate to survive, although it took about one year to properly recover from the illness with associated damage to my lungs.

12. The UK has given so much to me and my family. The country provided us with a safe home in 1999 and the NHS saved my life in 2020. I looked for ways to repay the country for its kindness. I decided to volunteer as a special constable with the Metropolitan Police. I completed some initial checks and training but unfortunately failed the fitness medical due to the lung damage caused by Covid-19.

#### My Shop at 6 Norfolk Place

- 13. I am focussed on being a good citizen and responsible community-minded business owner. Part of this process involved obtaining my personal licence and gaining work experience in my Uncle's shop located across the road on Star Street at 7 Norfolk Place. After that, in 2022, I committed to a 10-year lease for 6 Norfolk Place and spent my life savings on refurbishment works and money saved for stock outlay.
- The shop is now my only source of income to support my young family. My wife and I have a
  young daughter and two sons.
- 15. I was not able to afford any employees during the first few months of trading in 2022. I continue to work in the shop every day for about 15 hours a day seven days a week. As business picked up I was able to start employing 2 people to help run the shop. Having undertaken the personal licence training myself, I have been able to ensure these employees are trained. However I remain the main person that works in the shop every day from open until close.
- 16. My shop sells the local community a broad product range, including fresh meats, dairy, baked goods, groceries, non-alcoholic drinks, cereals, traditional food products popular with community groups in the area, basic hardware items, and a premium alcohol range. I do not sell cheap price alcohol. The carefully selected range of alcoholic drinks are for my customers to enjoy at home.

#### Representations

17.

I remain very grateful to the Licensing Sub-Committee for granting my premises licence on 21 April 2022. The original application attracted about 19 letters of support and about 13 objections from members of the local community, Environmental Health and the Southeast Bayswater Residents' Association. I am pleased that my current application to vary the licence

has received about 36 letters of support from local people and no objections at all from local

residents living in the area.

18. My solicitor contacted of the Southeast Bayswater Residents' Association and of the Hyde Park Estate Association on 27 July 2023. No response was received from the Hyde Park Estate Association. Mr Zamit replied and very kindly agreed to meet me at my shop on 9 August 2023. We had a friendly meeting but I understand that

has decided to maintain his objection.

19. I hope that the lack of local resident objections and overwhelming support demonstrates that I have worked hard to integrate myself into the local community and run my business professionally alongside local neighbours. I remain committed to being a responsible licensee and providing the community with a valued local business. I am confident I can maintain this commitment during the additional hours.







#### Annex 3 - Conditions attached after a hearing by the licensing authority

- 6. (a) The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team.
  - (b) All entry and exit points will be covered enabling frontal identification of every person entering in any light condition.
  - (c) The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises and will include the external area immediately outside the premises entrance.
  - (d) All recordings shall be stored for a minimum period of 31 days with date and time stamping.
  - (e) Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31-day period.
- 7. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
- 8. All sales of alcohol for consumption off the premises shall be in sealed containers only and shall not be consumed on the premises.
- 9. Should the premises ever trade after 23:00 (22:30 Sundays) or before 8am. Outside of the hours authorised for the sale of alcohol and whilst the premises are open to the public, the licence holder shall ensure that all alcohol within the premises (including alcohol behind the counter) is secured in a locked store-room or behind locked grilles, locked screens or locked cabinet doors so as to prevent access to the alcohol by both customers and staff.
- 10. No super-strength beer, lagers, ciders, or spirit mixtures of 5.5% ABV (alcohol by volume) or above shall be sold at the premises, except for premium beers and ciders supplied in glass bottles and cans.
- 11. No more than 15% of the sales area shall be used at any one time for the sale, exposure for sale, or display of alcohol.
- 12. There shall be no self-selection of spirits on the premises, save for spirit mixtures less than 5.5% ABV.
- 13. Prominent signage indicating the permitted hours for the sale of alcohol shall be displayed so as to be visible before entering the premises, where alcohol is on public display, and at the point of sale.
- 14. A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 15. A record shall be kept detailing all refused sales of alcohol. The record should include the date and time of the refused sale and the name of the member of staff who refused the sale. The record shall be available for inspection at the premises by the police or an authorised officer of the City Council at all times whilst the premises is open.

- 16. An incident log shall be kept at the premises and made available on request to an authorised officer of the City Council or the Police. It must be completed within 24 hours of the incident and will record the following:
  - (a) all crimes reported to the venue
  - (b) all ejections of patrons
  - (c) any complaints received concerning crime and disorder
  - (d) any incidents of disorder
  - (e) all seizures of drugs or offensive weapons
  - (f) any faults in the CCTV system
  - (g) any refusal of the sale of alcohol
  - (h) any visit by a relevant authority or emergency service.
- 17. All serving staff shall receive training in the sale of alcohol as set out in the 2003 Licensing Act prior to starting employment and receive refresher training at 6 monthly intervals. They will sign a training record confirm the above. All training records shall be available for inspection upon request by the Responsible Authorities.
- 18. All tills shall automatically prompt staff to ask for age verification identification when presented with an alcohol sale. Conditions proposed by the Environmental Health Service and agreed by the applicant to form part of the operating schedule.
- 19. A direct telephone number for the manager at the premises shall be publicly available at all times the premises is open. This telephone number and/or is to be made available to residents and businesses in the vicinity.
- 20. All waste shall be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times.
- 21. No waste or recyclable materials, including bottles, shall be moved, removed from or placed in outside areas between 23.00 hours and 08.00 hours on the following day.
- 22. Deliveries to the premises shall only take place between 08:00 and 22:00 hours.
- 23. Prominent, clear and legible notices must be displayed at all exits requesting staff and couriers to respect the needs of local residents and to leave the premises and the area quietly.
- 24. No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
- 25. During the hours of operation of the premises, the licence holder shall ensure sufficient measures are in place to remove and prevent litter or waste arising or accumulating from customers in the area immediately outside the premises, and that this area shall be swept and or washed, and litter and sweepings collected and stored in accordance with the approved refuse storage arrangements by close of business.
- 26. All serving staff shall receive training in the responsible sale of alcohol and the restrictions on the sale of alcohol to intoxicated persons prior to starting employment and receive refresher training at 6 Months intervals. 

#### Annex 3 – Conditions attached after a hearing by the licensing authority.

- 6. (a) The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Westminster Police Licensing Team.
  - (b) All entry and exit points will be covered enabling frontal identification of every person entering in any light condition.
  - (c) The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises and will include the external area immediately outside the premises entrance.
  - (d) All recordings shall be stored for a minimum period of 31 days with date and time stamping.
  - (e) Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31-day period.
- 7. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
- 8. All sales of alcohol for consumption off the premises shall be in sealed containers only and shall not be consumed on the premises.
- 9. Should the premises ever trade after 23:00 (22:30 Sundays) or before 8am. Outside of the hours authorised for the sale of alcohol and whilst the premises are open to the public, the licence holder shall ensure that all alcohol within the premises (including alcohol behind the counter) is secured in a locked store-room or behind locked grilles, locked screens or locked cabinet doors so as to prevent access to the alcohol by both customers and staff.
- 10. No super-strength beer, lagers, ciders, or spirit mixtures of 5.5% ABV (alcohol by volume) or above shall be sold at the premises, except for premium beers and ciders supplied in glass bottles and cans.
- 11. No more than 15% of the sales area shall be used at any one time for the sale, exposure for sale, or display of alcohol.
- 12. There shall be no self-selection of spirits on the premises, save for spirit mixtures less than 5.5% ABV.
- 13. Prominent signage indicating the permitted hours for the sale of alcohol shall be displayed so as to be visible before entering the premises, where alcohol is on public display, and at the point of sale.
- 14. A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 15. A record shall be kept detailing all refused sales of alcohol. The record should include the date and time of the refused sale and the name of the member of staff who refused the sale. The record shall be available for inspection at the premises by the police or an authorised officer of the City Council at all times whilst the premises is open.

- 16. An incident log shall be kept at the premises and made available on request to an authorised officer of the City Council or the Police. It must be completed within 24 hours of the incident and will record the following:
  - (a) all crimes reported to the venue
  - (b) all ejections of patrons
  - (c) any complaints received concerning crime and disorder
  - (d) any incidents of disorder
  - (e) all seizures of drugs or offensive weapons
  - (f) any faults in the CCTV system
  - (g) any refusal of the sale of alcohol
  - (h) any visit by a relevant authority or emergency service.
- 17. All serving staff shall receive training in the sale of alcohol as set out in the 2003 Licensing Act prior to starting employment and receive refresher training at 6 monthly intervals. They will sign a training record confirm the above. All training records shall be available for inspection upon request by the Responsible Authorities.
- 18. All tills shall automatically prompt staff to ask for age verification identification when presented with an alcohol sale. Conditions proposed by the Environmental Health Service and agreed by the applicant to form part of the operating schedule.
- 19. A direct telephone number for the manager at the premises shall be publicly available at all times the premises is open. This telephone number and/or is to be made available to residents and businesses in the vicinity.
- 20. All waste shall be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times.
- 21. No waste or recyclable materials, including bottles, shall be moved, removed from or placed in outside areas between 23.00 hours and 08.00 hours on the following day.
- 22. Deliveries to the premises shall only take place between 08:00 and 22:00 hours.
- 23. Prominent, clear and legible notices must be displayed at all exits requesting staff and couriers to respect the needs of local residents and to leave the premises and the area quietly.
- 24. No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
- 25. During the hours of operation of the premises, the licence holder shall ensure sufficient measures are in place to remove and prevent litter or waste arising or accumulating from customers in the area immediately outside the premises, and that this area shall be swept and or washed, and litter and sweepings collected and stored in accordance with the approved refuse storage arrangements by close of business.
- 26. All serving staff shall receive training in the responsible sale of alcohol and the restrictions on the sale of alcohol to intoxicated persons prior to starting employment and receive refresher training at 6 Months intervals. They will sign a training record confirm the above. All training records shall be available for inspection upon request by the Responsible Authorities
