- 14. The provision of public entertainment under this licence shall remain as an ancillary part of the lawful Class A3 use of the premises.
- 29. The terminal hour for late night refreshment on New Year's Eve is extended to 05:00 on New Year's Day.

Evidence of concerns are below, related to the Licensing Purposes with examples that at this site, these Purposes cannot be safely met :

- 1) Prevention of crime and disorderly conduct
- 2) Public Safety
- 3) Prevention of public nuisance
- 4) The protection of children from harm (unlikely to be an issue, regarding the other Licensing purposes (1), (2) and (3) above, unless a risk of harm within the proposed daytime and evenings, weekday, weekend and holiday hours, **externally but adjacent to the premises** may occur).

The width of the access from frontage to railings is approx. 1m wide x 4.5m in length, presumably 4.5 sq. only, for any queuing and smokers gathering on the footway, with likely external risk of disorderly conduct (1) and public nuisance (2), leaving a residual footway width at this point of only approx. 2.6m. As the section of St. James's Street carriageway passing northbound, is only approx. 4m in width and has traffic markings of double yellow lines – which are often busy in queueing for the traffic signal controlled crossing at the junction of Piccadilly, any overspill therefore of pedestrians passing and re-passing into the carriageway, from the adjacent residual, narrowed footway space outside the railings, may be a public safety risk (2). Taxi or chauffer or other vehicles arriving or departing, from set down or pick up of customers on entry of leaving, the entrance down the lightwell of the Club frontage is therefore also constrained and with even an orderly, likely queue width of customers/smokers and security at the railing steps to door way, of at least 500mm already reduces effective footway width further to 2 - 2.1 metres for busy passers-by in each direction with reduced safely (2) and the increased likely overspill into the northbound carriageway.

Evidence of significant concerns about Licensing Conditions are below and also related to the Licensing Purposes with examples, such as where are smokers to gather, in conjunction with queue entrance and staff management vested in yellow, at the limited frontage and the recognition that at this site Conditions of : Licensing Purposes (1) - (4) cannot met, not least if No. 55 below, is proposed by the business : "A member of the door staff shall patrol on both sides of St. James's Street between Piccadilly and Jermyn Street."

45. All staff engaged outside the entrance to the premises, or supervising or controlling queues shall wear high visibility yellow jackets or vests.

46. There shall be a personal licence holder on duty on the premises at all times when the premises are authorised to sell alcohol.

47. The licence holder shall ensure that any queue to enter the premises which forms outside the premises is orderly and supervised by door staff so as to ensure that there is no public nuisance or obstruction to the public highway.

55. A member of the door staff shall patrol on both sides of St. James's Street between Piccadilly and Jermyn Street.

For all the above reasons the St. James's Conservation Trust objects to the proposed application, which should not be consented for this site.





- 1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.
- 2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.
- 3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.
- 4. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
  - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;
    - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
    - drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
  - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
  - (a) a holographic mark, or
  - (b) an ultraviolet feature.
- 7. The responsible person must ensure that—
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
    - (i) beer or cider: <sup>1</sup>/<sub>2</sub> pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml;
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

- 8(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 8(ii) For the purposes of the condition set out in paragraph 8(i) above -
  - "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - (b) "permitted price" is the price found by applying the formula -

P = D + (DxV)

Where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
  - (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a

licence, or

- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 8(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 8(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- 9. All persons guarding premises against unauthorised access or occupation or against outbreaks of disorder or against damage (door supervisors) must be licensed by the Security Industry Authority.
- 10. Admission of children to the premises must be restricted in accordance with the film classification recommended by the British Board of Film Classification or recommended by this licensing authority as appropriate.


- 11. This licence is subject to all the former Rules of Management for Places of Public Entertainment licensed by Westminster City Council, in force from 4 September 1998 and incorporating amendments agreed by the Council on 25 October 1999, 30 June 2000, 16 January 2001 and 1 October 2001.
- 12. On New Year's Eve the premises can remain open for the purpose of providing regulated entertainment from the time when the provision of regulated entertainment must otherwise cease on New Year's Eve to the time when regulated entertainment can commence on New Year's Day (or until midnight on New Year's Eve where no regulated entertainment takes place on New Year's Day).
- 13. Notwithstanding the provisions of Rule of Management No 6 the premises may remain open for the purposes of this licence from 11pm on each of the days Monday to Saturday to 3.30am on the day following and from 11pm on Sunday to 3am on the day following (3.30 am on a Monday bank holiday).
- 14. The provision of public entertainment under this licence shall remain as an ancillary part of the lawful Class A3 use of the premises.
- 15. Licensable entertainment shall not be provided in the entrance lobby.
- 16. At least two registered door supervisors shall be stationed at the entrance to the premises from 11pm on each night when the premises remain open beyond 11pm, so as to ensure that customers enter and exit the premises in a quiet and orderly manner.
- 17. No external doors or windows shall be fixed open after 11pm on any day of the week.
- 18. A sound limiter device shall be fitted to the sound system and shall be set and maintained at levels agreed by the Environmental Health Officer. The operational panel shall then be secured and the system will not be altered without the approval of the Environmental Health Officer.
- 19. The sound system shall not be altered or modified without the approval of the Environmental Health Officer.
- 20. No additional sound generation equipment shall be used on the premises without being routed through the sound limiter device.
- 21. Notices shall be provided at the premises requesting patrons to leave quietly. Similar reminders shall be made over the loud speakers and by door supervisors at the door.
- 22. The CCTV system shall be maintained and operated correctly to the satisfaction of the Metropolitan Police Crime Prevention Officer. The tapes from the system shall be retained for a period of 28 days.
- 23. The iron gate at the foot of the external entrance staircase shall be locked back in an open position while the premises are in use under this licence.
- 24. The final double leaf wooden doors on the alternative escape route shall be locked back in an open position while the premises are in use under this licence.
- 25. No unauthorised advertisements of any kind (including placard, poster, sticker, flyer, picture, letter, sign or other mark) is inscribed or affixed upon the surface of the highway, or upon any building, structure, works, street furniture, tree, or any other property, or is distributed on street to the public, that advertises or promotes the establishment, its premises, or any of its events, facilities, good or services.

- 26. Substantial food and non-intoxicating beverages (including drinking water) shall be available during the whole of the permitted hours in all parts of the premises where intoxicants are provided.
- 27. On any evening where the premises or part of the premises are open for the purpose of music, dance and entertainment, alcohol may not be sold or supplied to persons admitted to the premises after 11pm other than to:
  - (a) Persons who have paid a minimum admission fee of at least £5 Monday to Thursday and £7 Friday and Saturday for music, dance and entertainment. (Not to be credited against consumables);

- (f) The permitted hours for the sale of alcohol on New Year's Eve are from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, 00.00 midnight on 31st December

#### The applicant is proposing to vary condition 32 as follows:

- 32. On the morning that Greenwich Mean Time changes to British Summer Time one hour will be added to the terminal hour of any activities and to the closing time for the premises where the existing terminal hour for the activities and/or closing hour for the premises ends after 01.00
- 33. No payment shall be made by or on behalf of the licensee to any person for bringing customers onto the premises directly from the street.
- 34. When a customer chooses to pay by credit card, he/she will be presented with an itemised bill on final payment, showing details of all drinks and food purchased.
- 35. Where the sale of alcohol takes place after 00:30 on the day following Sundays (other than the Sundays before Bank Holidays) this will be only to persons attending private pre-booked functions at the premises or to members of the private club operating at the premises and their guests.

#### The applicant proposes to vary condition 35 as follows:

Where the sale of alcohol takes place after 00:30 on the day following Sundays (other than the Sundays before Bank Holidays) this will be only to persons attending for seated dining /or private pre-booked functions at the premises or to members of the private club operating at the premises and their guests.

- 36. No external promoters will be used to organise the private functions on Sundays referred to in condition 37 above, such private functions to be organised by the premises licence holder/designated premises supervisor.
- 37. Where a private function takes place at the premises on Sundays (other than Sundays before Bank Holidays) where alcohol is to be sold after 00:30 the following day, a full guest list must be produced by the premises at least 24 hours prior to the function together with a booking sheet for each function regarding the following information as a minimum name of the individual who has hired the premises together with contact details; date of hiring and purpose of event. The guest list and booking sheet will be made available to the police or an authorised officer of the Council upon request at the premises on the night of the function and for a period of 14 days thereafter.
- 38. Where alcohol is being sold on Sundays (other than Sundays before Bank Holidays) after 00:30 the day following to members of the private club operating at the premises, members shall be permitted to have no more than 4 guests accompanying them, and all members must have been accepted as members of the private club no later than 24 hours beforehand.

- 39. The number of persons accommodated at the premises shall not exceed 210 persons (exclusive of staff).
- 40. There shall be no admittance to the premises after 00:00.

## The applicant proposes to vary condition 40 as follows:

- 40. There shall be no new admittance or readmittance to the premises save for smokers after 01:00
- 41. Patrons permitted to temporarily leave and then re-enter the premises, e.g. to smoke, shall not be permitted to take drinks or glass containers with them.
- 42. Every member of staff will undergo documented responsible server training within a month of the decision and (for new staff) within 3 months of starting employment.

#### The applicant proposes to vary condition 42 as follows:

- 42. Every member of staff involved in the sale and supply of alcohol will undergo documented responsible server training within 2 months of starting employment
- 43. All staff will receive refresher responsible server training once per year.
- 44. The licensee shall maintain further CCTV cameras outside the premises so as to both south and north in St James's Street.
- 45. All staff engaged outside the entrance to the premises, or supervising or controlling queues shall wear high visibility yellow jackets or vests.

#### The applicant proposes to vary condition 45 as follows:

- 45. All staff engaged outside the entrance to the premises, or supervising or controlling queues shall wear distinctive clothing to identify them as a member of staff or security.
- 46. There shall be a personal licence holder on duty on the premises at all times when the premises are authorised to sell alcohol.
- 47. The licence holder shall ensure that any queue to enter the premises which forms outside the premises is orderly and supervised by door staff so as to ensure that there is no public nuisance or obstruction to the public highway.

## The applicant is proposing to remove the following condition (condition 48)

- 48. No drinks shall be served in glass containers at any time.
- 49. Exterior door staff shall be equipped with "body cams".
- 50. Should the CCTV system develop a significant fault, the premises licence holder will inform the Police of the fault and of the proposed time for rectification.

51. The premises licence holder shall install and use a clubscan or similar device at the entrance to the premises.

## The applicant proposes to vary condition 51 as follows:

51. After midnight

(a) All customers entering the premises shall have their ID and/or membership card scanned on entry, save for when a biometric scanning system is in place. The details recorded shall include a live facial image capture of the customer and capture the photographic identification produced. The details recorded by the ID scanner system shall be made available to the Police and the local authority upon request.

(b) The requirement in (a) will not apply to customers who have prebooked more than 24 hours in advance to attend the premises for a seated meal with substantial food. Details of the restaurant booking will be retained for 31 days after the attendance for inspection by the police and responsible authorities upon request. For the purpose of this condition 'Substantial Table Meal' means – a meal such as might be expected to be served as the main midday or main evening meal, or as a main course at either such meal and is eaten by a person seated at a table, or at a counter or other structure which serves the purposes of a table and is not used for the service of refreshments for consumption by persons not seated at a table or structure servicing the purposes of a table.

(c) The requirement in (a) above is subject to the following exceptions, namely that a maximum number of (15) guests per night may be admitted at the Managers discretion without necessarily photo ID being scanned and recorded. The admission of such guests however shall be in accordance with the following procedure:

(i) The DPS shall approve in writing the names of a maximum of three managers other than him/herself who are authorised to sign in such guests.

(ii) A legible record (the signing in sheet) of those guest's name shall be retained on the premises for inspection by the licensing authority and Police for a minimum period of 31 days. The name of the DPS approved manager authorising the admission will also be recorded by that manager.

(iii) Guests shall be required to produce some form of ID such as a bank card (or emailed electronic photo ID) and ID scan entry with a live photo shall be created.
(iv) Where there are appropriate reasons for a guest not to be able to produce ID and be subject to ID scan, the Approved Manager may still permit entry. In such circumstance he shall also record the reasons for this in the signing in sheet

(d) Notwithstanding (a) above, patrons who are attending a pre-booked private event at the premises do not need to have their ID Scanned on entry and instead a written guest list for all attending shall be held at reception for the event, and will be retained for 31 days after the event

- 52. All door staff shall work for a contractor who is a member of the Security Industry Authority's Approved Contractor Scheme.
- 53. There shall be one door supervisor for every thirty customers, with a number of four door supervisors at all times.

## The applicant proposes to vary condition 53 as follows:

- 53. (a)At least 2 SIA licensed door supervisors shall be on duty at the entrance of the premises from 20:00 whilst it is open for business
  (b) There shall be one door supervisor on duty for every 100 customers
- 54. All door staff shall wear distinctive clothing so that they can be readily identified at the premises.

- 55. A member of the door staff shall patrol on both sides of St James' Street between Piccadilly and Jermyn Street.
- 56. The Licensee will give local residents who want it a dedicated hotline telephone number which will always be manned during trading hours and for 30 minutes thereafter.
- 57. A Management Plan requiring the Licensee to use their best endeavours to manage customers, external to the premises, including arrival, departure and dispersal of customers quickly, quietly and towards Piccadilly shall be submitted to Environmental Health for approval and the Licensee shall thereafter implement and maintain the said Plan.

## Conditions proposed to be to be added by the applicant


- 58. Any special effects or mechanical installations shall be arranged and stored so as to minimise any risk to the safety of those using the premises. The following special effects will only be used on 10 days prior notice being given to the Licensing Authority where consent has not previously been given.
  - a. dry ice and cryogenic fog
  - b. smoke machines and fog generators
  - c. pyrotechnics including fireworks
  - d. firearms
  - e. lasers
  - f. explosives and highly flammable substances
  - g. real flame g. strobe lighting.
- 59. The approved arrangements at the premises, including means of escape provisions, emergency warning equipment, the electrical installation and mechanical equipment, shall at all material times be maintained in good condition and full working order.
- 60. The means of escape provided for the premises shall be maintained unobstructed, free of trip hazards, be immediately available and clearly identified in accordance with the plans provided.
- 61. All emergency doors shall be available at all material times without the use of a key, code, card or similar means.
- 62. All emergency doors shall be maintained effectively self-closing and not held open other than by an approved device.
- 63. The edges of the treads of steps and stairways shall be maintained so as to be conspicuous.
- 64. Curtains and hangings shall be arranged so as not to obstruct emergency safety signs or emergency equipment.
- 65. All fabrics, curtains, drapes and similar features including materials used in finishing and furnishing shall be either non-combustible or be durably or inherently flame-retarded fabric. Any fabrics used in escape routes (other than foyers), entertainment areas or function rooms, shall be non-combustible.
- 66. Flashing or particularly bright lights on or outside the premises shall not cause a nuisance to nearby properties, save insofar as they are necessary for the prevention of crime.
- 67. Before the premises open to the public, the plans as deposited will be checked by the Environmental Health Consultation Team to ensure they are an accurate reflection of the

premises constructed. Where the premises layout has changed during the course of construction new plans shall be provided to the Environmental Health Consultation Team and the Licensing Authority.

68. The licence will have no effect until the Licensing Authority are satisfied that the premises is constructed or altered in accordance with the appropriate provisions of the District Surveyors Association – technical Standards for Places of Entertainment and the reasonable requirements of Westminster Environmental Health Consultation Team, at which time this condition will be removed from the licence.
